Subject: Suspension of Appropriation of Future Measure J Funds Due to COVID-19

On May 20, 2020, the Authority Board temporarily suspended new appropriations of Measure J funds to capital projects. This action was necessitated by COVID-19 potential negative long-term impact on sales tax revenues. The suspension affects many projects programmed in the 2019 Measure J Strategic Plan and/or included in the programming documents for the Transportation for Livable Communities or Pedestrian, Bicycle and Trails Facilities programs (Programs 12 and 13), as shown in the attached list.

At the same meeting, the Authority Board directed staff to develop an "Allocation Plan" that will prioritize future appropriations of Measure J funds to impacted projects. The Allocation Plan will be developed based on principles that were approved by the Authority Board on June 17, 2020. The principles prioritize shovel-ready projects that leverage state/federal funds, as outlined in the attached staff report.

Authority staff is currently in the process of gathering up-to-date project status information from project sponsors to help develop the Allocation Plan. An initial draft of the prioritization of projects to be included in the Allocation Plan is scheduled to be presented to the Authority's Technical Coordinating Committee on August 20, 2020. The final prioritization of projects to be included in the Allocation Plan will be presented to the Authority Board in September 2020. The final Allocation Plan will be presented to the Authority Board after a long range-revenue forecast has been prepared and approved by the Authority Board. The Allocation Plan will serve as the Authority's priority for future funding from Measure J funds and other fund sources such as federal stimulus funds.

Project sponsors have the option to advance their projects if they wish to proceed at-risk using local funds. Sponsors would have to request Authority Board approval of a letter of no prejudice (LONP) prior to proceeding. If approved, the Authority would commit, by resolution, to reimburse for incurred costs with Measure J funds at a future date consistent with the approved project scope in the Strategic Plan and/or other programming documents. If the long-term revenue forecast does not support the future Measure J appropriation to the project, the project sponsor will not be reimbursed for incurred costs. Peer reviews of design plans are still required for projects with approved LONPs unless the project is exempt based on the Authority's Local Agency Coordination Guide.

Summary of Issues	Due to the projected declining sales tax revenue caused by COVID-19, the Authority Board approved Resolution 20-09-P temporarily suspending new appropriations of Measure J funds to capital projects. The suspension impacts projects included in the 2019 Measure J Strategic Plan and/or the programming documents for the Transportation for Livable Communities (TLC)/Pedestrian, Bicycle and Trails Facilities (PBTF) programs. In addition, the Authority Board authorized staff to develop an Allocation Plan to guide future Measure J appropriations to capital projects once a long-range revenue forecast is developed. Staff has developed the framework and principles for the development of the Allocation Plan. In addition, a list of Authoritymanaged contracts has been identified for contract reduction or suspension.

Background

Due to projected declining sales tax revenue caused by COVID-19, at the May 2020 Authority Board meeting, the Authority Board approved Resolution 20-09-P, which temporarily suspends new appropriations of Measure J funds for capital projects. The suspension impacts projects included in the 2019 Measure J Strategic Plan and/or programming documents for the TLC/PBTF programs (Program 12 and 13, respectively). In addition, the Authority Board authorized staff to develop an Allocation Plan to guide future Measure J appropriations to capital projects once a long-range revenue forecast is developed and approved by the Authority Board.

Per the Authority Board's direction on May 20, 2020, staff has developed the framework and principles for the preparation of the Allocation Plan. The long-range forecast will determine whether the Authority will be able to make future Measure J appropriations for capital projects based on the Allocation Plan. It will also determine whether COVID-19 will impact future allocations to Measure J programs.

Allocation Plan Principles and Framework

The Allocation Plan will prioritize future appropriations of Measure J funds to capital projects based on a detailed assessment of each project status, funding, percent complete, and schedule. Staff has developed the following principles to guide the development of the Allocation Plan. These principles were presented to the Authority's Technical Coordinating Committee (TCC) on May 21, 2020 and the Citizen Advisory Committee on May 27, 2020.

Proposed Principles to Prioritize Measure J Projects in the Allocation Plan

The following four principles were developed around three primary objectives: timely use of funds, leveraging, and readiness/deliverability. Projects that meet one or more of the principles below will receive higher priority for Measure J appropriations in the future if the updated longrange Measure J forecast supports it.

- a. Projects that will leverage State or Federal funds that may be lost due to timely use of fund requirements.
- b. Projects where Measure J funds are required to match State/Federal funds.
- c. Projects that are shovel ready and can start construction before July 2021.
- d. Projects that are a component of larger projects where the larger project would be at risk if Measure J funds are not allocated.

Authority-Sponsored Projects

Based on a screening of existing contracts managed by the Authority, staff is recommending the temporary suspension and/or reduction of contracts identified in Attachment A. The list was developed based on examination of contract status, fund sources, and ability to compete for other fund sources such as Senate Bill 1. Higher priority was placed on projects/contracts that leverage other funding sources, such as Federal and State funding and require Measure J to meet matching fund requirements. In addition, deadlines to use secured funds were considered in developing the recommendations.

Due to limited available Measure J funding, the Authority will primarily rely on other revenues from Federal, State, and regional fund sources to advance these projects in the future. Priority will be given to projects that are expected to compete well and can meet the match requirements.

To provide required matching funds, staff is working on developing a fund exchange program that may involve reprogramming of State Transportation Improvement Program (STIP) funds or entering into loan agreements with other entities. Staff will seek authorization from the Authority Board for any fund exchange agreements prior to proceeding.

Locally Sponsored Projects

Staff has reviewed locally sponsored projects included in the 2019 Measure J Strategic Plan and/or the TLC/PBTF programming documents that are expected to seek Measure J appropriations in the future (See Attachment B). These projects will be subject to the Allocation Plan and will be prioritized based on the principles highlighted above. Staff is in the process of contacting local jurisdictions to determine how each project meets these principles. Although exceptions can be made on a case by case basis to prevent loss of other fund sources, the Authority is not expected to make any new Measure J appropriations until the Allocation Plan is developed and the new long-term revenue forecast is approved.

Projects that can be federalized and are good candidates for potential future stimulus funding will be identified in the process to determine if Measure J funds can be replaced by other future funds programmed by the Authority. Authority staff will coordinate with local jurisdictions to identify opportunities where the Authority can support the delivery of future capital projects to potentially reduce costs.

Should the long-range revenue forecast not support any future appropriation of Measure J funds for capital projects, staff will recommend using the Allocation Plan as its priority list to fund the projects using other future fund sources programmed by the Authority.

Consistent with Policy 15 in the 2019 Measure J Strategic Plan, project sponsors have the option to advance their projects at risk with their own local funds. Sponsors would have to request Authority Board approval prior to proceeding. If approved, the Authority would commit, by resolution, to reimburse the local jurisdiction at a future date consistent with project programming in future strategic plans and other applicable policies (e.g. completion of peer reviews, etc.). If the long-term revenue forecast does not support future Measure J appropriations to the project, the project sponsor will not be reimbursed for their costs.

Measure J Programs

Consistent with Resolution 20-09-P, future programming of next cycles for the TLC/PBTF programs will continue to be suspended until the new revenue forecast is developed and the next strategic plan has been adopted.

The impact of COVID-19 on Measure J allocations to other Measure J programs in the Expenditure Plan will be determined after a new long-range revenue forecast is developed. The development of the Allocation Plan will help minimize impacts to these programs. Staff will continue to identify any opportunities to leverage any grant funds to replace Measure J funding on any of the Measure J programs in the near future.

Schedule

Staff anticipates bringing back the Allocation Plan to the Authority Board in September 2020. The schedule allows time to coordinate with local jurisdictions and the TCC. It also allows for gathering more data to develop a more reliable long-term revenue forecast.

STATE ROUTE 4 WIDENING

A. SR4 Widening: Railroad Avenue to Loveridge Road COMPLETED

Lead Agency: CCTA

Project Description: The project widened the existing highway from two to four lanes in each direction (including HOV lanes) from approximately one mile west of Railroad Avenue to approximately ³/₄ mile west of Loveridge Road and provided a median for future transit.

Current Project Phase: Completed.

Project Status: Landscaping of the freeway mainline started in December 2009 and was completed in June 2010. A three-year plant establishment and maintenance period is currently in progress as required by the Cooperative Agreement with Caltrans, was complete on June 24, 2013. Caltrans has accepted the project and will take over the maintenance responsibilities. The CCTA Board accepted the completed construction contract, approved the final contractor progress payment, approved the release of the retention funds to the contractor, and authorized staff to close construction Contract No. 241 at its September 18, 2013 meeting.

Issues/Areas of Concern: None.

B. SR4 Widening: Loveridge Road to Somersville Road COMPLETED

Lead Agency: CCTA

Project Description: The project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) between Loveridge Road and Somersville Road. The project provides a median for future mass transit. The environmental document also addresses future widening to SR 160.

Current Project Phase: Completed.

Project Status: Caltrans accepted the contract on June 30, 2014. The construction contract is now closed with no outstanding claims.

Issues/Areas of Concern: None.

C. SR4 Widening: Somersville Road to SR 160

Lead Agency: CCTA

Project Description: This project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) from Somersville Road to Hillcrest Avenue and then six lanes to SR 160, including a wide median for transit. The project also includes the reconstruction of the Somersville Road Interchange, Contra Loma/L Street Interchange, G Street Overcrossing, Lone Tree Way/A Street Interchange, Cavallo Undercrossing and the Hillcrest Avenue Interchange.

Current Project Phase: Construction (landscape).

Project Status: The project is divided into four segments: 1) Somersville Interchange; 2) Contra Loma Interchange and G Street Overcrossing; 3A) A Street Interchange and Cavallo Undercrossing and 3B) Hillcrest Avenue to Route 160.

Segment 1: Somersville Interchange

Segment was open to traffic in December 2013.

Segment 2: Contra Loma Interchange & G St. Overcrossing

Construction began in March 2012 and was completed in February 2016.

Segment 3A: A Street Interchange and Cavallo Undercrossing

Construction began in August 2012 and was accepted as complete in May 2017.

Segment 3B: Hillcrest Avenue to SR160

Construction began in March 2013 and was substantially completed in September 2016 and closeout activities are ongoing. Bike safety improvements have been implemented.

Corridor-wide:

Ribbon cutting ceremony held on July 20, 2016.

Corridor Landscaping:

- Contract 1 (Loveridge to Century) bids were opened in December 2017. Construction started in early 2018 with project completion, inclusive of the plant establishment period, in 2021.
- Contract 2 (Somersville to Cavallo) was advertised on March 12, 2018 and construction has started. Completion, inclusive of plant establishment, is anticipated to be in 2022/23.
- Contract 3 (Hillcrest to Laurel Rd. and on SR 160) design was completed and construction bid opened in December 2018. The contract was awarded in February 2019 and completion, inclusive of plant establishment, is anticipated to be in 2022/23.

Issues/Areas of Concern:

The project ROW closeout process is complex. Closeout for the Railroad, Loveridge and Somersville Interchange is complete. The current effort focuses on the Contra Loma Interchange. Additional ROW engineering work is needed to address BART expansion projects and easements for irrigation lines to reduce construction costs. This may require amending the Caltrans Cooperative Agreement ROW engineering budget.

Update from Previous Quarterly Report

- The last landscape contract is approaching completion.
- As part of the ROW process, excess ROW at Tregallas Road and Lindberg Street will be sold in spring of 2020.
- C. SR4 Bypass: SR4/SR160 Connector Ramps COMPLETED

Project Fund Source: Bridge Toll Funds

Lead Agency: CCTA

Project Description: Complete the two missing movements between SR4 Bypass and State Route 160, specifically the westbound SR4 Bypass to northbound SR160 ramp and the southbound SR160 to eastbound SR4 Bypass ramp.

Current Phase: Completed.

Project Status:

- The project opened to traffic on February 29, 2016.
- Final paving is complete and a ribbon cutting was held on February 29, 2016.

Issues/Areas of Concern: None.

Project Description: The Phase 1 project will include a new SR4 bridge crossing over Balfour Road, providing one southbound and one northbound lane for SR4; northbound and southbound SR4 loop on-ramps, servicing both westbound and eastbound Balfour Road traffic; and northbound and southbound SR4 diagonal off-ramps.

Current Phase: Construction.

Project Status:

- *Project is in the construction closeout phase.*

- Amendment No. 4 to contract 430 with Quincy Engineering was approved by the Authority Board on February 15, 2020 in the amount of \$34,500 for additional Design Services During Construction (DSDC) services to facilitate the efforts to rework the configuration of the eastbound off ramp at Balfour Road.
- Cost and funding information updated based on latest information resulting in anticipated ECCRFFA savings of \$3 million.

H. SR-4: Mokelumne Trail Bike/Pedestrian Overcrossing (portion of Project 5002)

CCTA Fund Source: Measure J

Lead Agency: CCTA

Project Description: Construct a pedestrian and bicycle overcrossing near the Mokelumne Trail at SR4. The overcrossing will include a multi-span bridge with columns in the SR4 median. Bridge approaches will be constructed on earthen embankments. The path width is assumed to be 12 feet wide. This project is required as a condition of approval under the SR-4 Bypass project.

Current Phase: Design, Right of Way and Utilities.

Project Status:

- The CEQA clearance is complete.
- Right of Way appraisals are underway.

Issues/Areas of Concern:

- Construction funding for the project has not been secured.
- Project costs may escalate as schedule is impacted by funding shortfall.
- The NEPA clearance, if needed, may be problematic.
- BART's eBART Next Segment Study identifies a potential future station in the vicinity of the Mokelumne Trail POC.

- The design team continues with the preparation of final PS&E.
- Development of a Joint Exercise Powers Agreement (JEPA) between SR4 Bypass Authority (SR4BA), ECCRFFA, City of Brentwood and CCTA to define and establish the roles and responsibilities for the project is underway. The JEPA will be taken to the Authority Board for approval, before PS&E is complete. SR4BA approved the Right of Way acquisitions needed for the project in November 2019. SR4BA staff continues with subsequent activities associated with the eminent domain process for one of the properties.

STATE ROUTE 239 (# 5007)

Study Status: Scope

State Route 239 (SR239) was first legislated in 1959 as a possible roadway linking SR4 in Brentwood to I-205 or I-580 west of Tracy. A Feasibility Study and a Project Initiation Document were completed in 2015. The current scope is to complete the preliminary engineering and environmental document (PAED) for SR239 to determine its alignment, complete the State Route Adoption process, and to identify and obtain environmentally approval for an initial segment to proceed with design and construction.

Administration: Responsibility for the State Route 239 Study the associated federal funding was transferred from Contra Costa County to the Contra Costa Transportation Authority in January 2012. **Status**

- Feasibility Study and Project Initiation Document (PID) have been completed.

Issues/Areas of Concern

- Significant funding is needed to complete project.
- The proposed hybrid programmatic and project level PAED is new to Caltrans District 4. Staff is working with Caltrans to develop process for this unique approach aimed to fast track PAED completion and reduce costs.

Update from Previous Quarterly Report

- This is a new report.
- Consultant selection and negotiation for Preliminary Engineering and Environmental Document (PAED) have been completed and awaits Caltrans audit.
- Staff will seek Board approval of the consultant contractupon satisfactory completion of the Caltrans audit.

EAST COUNTY RAIL EXTENSION (eBART) (# 2001/2101)

Scope

Extend rail service eastward from the Pittsburg/Bay Point BART Station to Hillcrest Avenue within the median of SR 4 (Project 1). In addition, the parking lot at Antioch BART station at Hillcrest Avenue will be expanded by 800 spaces (Project 2).

Status

- Project #1: Revenue service started in May 2018.
- Project #2: Currently in the construction phase.



Dear Mr. Tree:

On behalf of the TRANSPLAN Committee, thank you for the opportunity to provide comments on this milestone development for the Valley Link project.

TRANSPLAN is the sub-regional transportation planning committee ("RTPC") in eastern Contra Costa County and includes five member agencies (cities of Antioch, Brentwood, Oakley and Pittsburg, and Contra Costa County), as well as partner agencies such as Tri-Delta Transit, BART and 511 Contra Costa. TRANSPLAN coordinates the transportation interests of the communities in eastern Contra Costa County and administers the East County Action Plan for Routes of Regional Significance ("Action Plan").

Regional Coordination

TRANSPLAN recommends that Valley Link staff engage Contra Costa County transit providers (Tri Delta Transit, BART), jurisdictions, and other regional agencies and stakeholders during Valley Link planning processes to increase the number of transportation options available between Contra Costa and Alameda Counties. In particular, TRANSPLAN encourages Valley Link staff to engage with Contra Costa stakeholders working to plan and implement the future Brentwood Intermodal Station. The Contra Costa County Transportation Authority (CCTA) will soon begin its "East County Integrated Transit Study" (anticipated to be completed by Spring 2022), and while the scope of this study does not include connections to Alameda County, the study's recommendations could inform the alignment of a future transit connection between Brentwood and the planned Mountain House Valley Link station. CCTA and Contra Costa County Public Works are also entering the environmental phase of the 239/Tri-Link project, a new state route to connect communities between Brentwood and Tracy, which will also consider alignments that accommodate public transit infrastructure, including bus rapid transit and e-BART.

Coordination between these projects and planning efforts may present opportunities to prepare joint grant applications, which may improve both Valley Link and Contra Costa County's competitiveness for grant funding, and could realize cost-efficiencies for future transit projects connecting between Contra Costa and Alameda Counties. TRANSPLAN also recommends recruiting an elected official, staff member, or otherwise appropriate Contra Costa County

On behalf of the TRANSPLAN Committee, thank you for the opportunity to provide comments on multiple proposed projects for the City of Brentwood ("City"). This letter provides combined comments for multiple aspects of the project, which include the following:

- 1. 252 detached single-family homes
- 2. 258 unit apartment complex in the northwest portion of the site
- 3. 19.59 acres of future commercial development north of the Sand Creek Road portion of the site
- 4. Dedication of 4.3 acres of land to the City of Brentwood for use as public parks
- 5. An 11.35-acre section for a potential elementary school, or 63 single-family units if the school development does not proceed
- 6. General Plan amendment, Rezoning, Development Agreement, Vesting Tentative Subdivision Map, and Design Review

TRANSPLAN is the sub-regional transportation planning committee ("RTPC") in eastern Contra Costa County and includes five member agencies (cities of Antioch, Brentwood, Oakley and Pittsburg, and Contra Costa County), as well as partner agencies such as Tri-Delta Transit, BART and 511 Contra Costa. TRANSPLAN coordinates the transportation interests of the communities in eastern Contra Costa County and administers the East County Action Plan for Routes of Regional Significance ("Action Plan").

The Action Plan facilitates establishment of goals, performance measures (called Multimodal Transportation Service Objectives, or "MTSOs") for designated Routes of Regional Significance ("RRS") and outlines a set of projects, programs, measures, and actions that will support achievement of the MTSOs. TRANSPLAN submits the following comments for your consideration:

Transit Service

1. Transit productivity is an east county area-wide objective of the Action Plan. Therefore, the TIA must consider both proposed project's impacts on transit service, including

 BART ridership. The Action Plan's measures for the purpose of monitoring this objective include:

Bus Riders per Service Hour:

• The average number of riders boarding a fixed-route bus during an hour of scheduled bus service when persons may board with a fare or pass.

BART Ridership:

• The average number of weekday riders on all BART trains between Bay Point and North Concord Stations. (Note: this MTSO was established prior to the completion of the eBART extension to Antioch. Evaluation should consider trains between the Antioch Station and North Concord.)

Two Tri-Delta Transit bus routes serve areas near the proposed project sites. While the DEIR finds that the projects will induce little demand onto the existing transit systems, improved transit service could help mitigate the project's impact on roadway congestion. TRANSPLAN recommends that the project proponents and the City consult with Tri-Delta Transit to expand bus service to, or increase bus service frequency near the project sites, as well as to create connections with the Antioch/Hillcrest BART Station, the future Brentwood Intermodal Station, and connections along San Jose Avenue and Sand Creek Road (RRS). Potential improvements could also be considered as part of a Transportation Demand Management program recommended in Comment #4. The future extensions for San Jose Avenue and Sand Creek Road should be considered in any transit planning efforts.

Bicycle and Pedestrian Facilities

2. The Action Plan encourages active transportation to improve multi-modal mobility and to decrease single-occupant vehicle travel. The traffic impact analysis should identify potential barriers to bicycling and walking, such as lengthy crosswalks or high speed roads, and should identify solutions to eliminating these barriers for bicycle and pedestrian travel to, from, and within the project areas. Because that the applicant is proposing to build a school as part of the project, the project proponents and the City should design bicycle and pedestrian infrastructure and traffic calming features that safely accommodate vulnerable roadway users of all ages. The future extensions for San Jose Avenue and Sand Creek Road should considered in any bicycle and pedestrian infrastructure planning efforts. Project proponents should also consider providing on-site short and long-term bicycle parking infrastructure (e.g. bicycle racks (short-term) and bicycle lockers (long-term) or a similar secure bicycle enclosure).

Transportation Demand Management

3. TRANSPLAN staff encourages the project to implement transportation demand management ("TDM") strategies, which can benefit the region by promoting the use of travel modes that are more efficient and environmentally friendly. TDM strategies can potentially decrease the number of single-occupant auto trips, and therefore reduce the proposed project's impact on roadway network congestion. Project proponents should

consult with the County's Transportation Demand Management Agency, 511 Contra Costa, to develop TDM strategies.

Electric Vehicle Charging

4. TRANSPLAN staff recommends that the applicant provide electric vehicle charging infrastructure for multifamily residential units in this project at a rate consistent with the California Green Building Code.
