

May 12, 2011

The meeting of the TRANSPLAN Committee was called to order in the Tri Delta Transit Board Room, 801 Wilbur Avenue, Antioch, California by Chair Brian Kalinowski at 6:30 P.M.

CONSIDER AND RECOMMEND SAFE ROUTES TO SCHOOL FUNDING PROJECTS/ PROGRAMS FOR THE TRANSPLAN SUB-REGION

Mr. Cunningham advised that the Metropolitan Transportation Commission (MTC) had allocated \$2.47 million in federal Congestion Mitigation and Air Quality (CMAQ)

Improvement Program funds to support Safe Routes to School programs or projects in Contra Costa County. He described the stringent requirements involved to be able to spend the funds at the local level, reported that the TRANSPLAN area had been allocated \$726,000 by a funding allocation detailed in the staff report from the Contra Costa Transportation Authority's (CCTA's) Planning Committee dated April 6, 2011, and advised that the TRANSPLAN Technical Advisory Commission (TAC) had discussed the item and had a recommendation for the Board. He added that a local match of 11.5 percent was required.

Brad Beck, CCTA's Senior Transportation Planner, explained that MTC's Climate Initiative Program had allocated CMAQ funds with had an overriding limitation that they be spent in ways to reduce air quality pollutants and improve air quality, and MTC had further shrunk the funds by making them available only for Safe Routes to School Programs, things to encourage children to walk or bicycle to school, get their parents involved to do that, or conduct physical improvements. He explained that one of the problems in using the funding to make physical improvements was that there was little time involved. Projects must also be federalized, requiring National Environmental Policy Act (NEPA) clearance, which was more difficult than the California Environmental Quality Act (CEQA) process, and which had to be completed by February 5, 2012. As a result, a project which did not require acquisition of right-of-way, new utilities and the like, was required. He added that he had been working with the Regional Transportation Planning Committees (RTPCs) to identify projects.

Mr. Beck referred to the recommendations from the Planning Committee to the RTPCs as to how to allocate their share of CMAQ funds available through the MTC program by basing each share 50 percent on population within the subregion and 50 percent on K-12 enrollment; by recommending projects or programs that can meet the Caltrans and MTC requirements either in a stand-alone program or project or an already federalized project that can exchange some or all of its local funds with other like projects for the CMAQ funds; by setting a minimum request of \$250,000 with a minimum program or project size of \$282,500; or by using set aside funds, if needed, from the Safe Routes to School Master Plan contract for the funds to help oversee and support programs or projects funded through the program.

Mr. Cunningham presented the TRANSPLAN TAC's recommendation and explained that the discussion of the approach recommended had been complex. The recommendation for the available funding was to fund a Brentwood Project which included a traffic signal on American Avenue at Heritage High School, replacement of 66 existing solar powered in-pavement crosswalk lights, and a sidewalk gap closure project adjacent to Marsh Creek Elementary School, at an estimated cost of \$435,000; with the balance to be spent on a 511 Contra Costa East County Bicycle/Pedestrian Program estimated at \$291,000. He recommended that the Board create a subcommittee to review the situation and noted that the TAC would meet next week to discuss the issue.

Federal Glover asked whether the identified projects were the only fundable projects or programs available, and questioned why there were no other shelf-ready projects available for consideration. He did not want to lose the funding.

Mr. Cunningham explained that the identified projects were the only projects that fit the very stringent criteria.

Chair Kalinowski wanted to see the three Brentwood projects work, if possible, and if not agreed that the 511 project could be pursued. He indicated that he did not favor the third option to swap the money with other projects/RTPCs. He agreed that transparency was important if the Brentwood projects did not work.

Bob Taylor commented that the issue had been discussed for months with the CCTA's Planning Committee and he objected to a being backed up against a wall.

Mr. Cunningham explained that he monitored the other RTPCs and the discussions in those forums had been even more surreal. He stated that the funding, when identified, had been for Safe Routes to School and noted that the constraints on the funding were CMAQ driven. He suggested that the difficulty in attaining the funding had taken those involved off guard.

Mr. Beck stated that the use of the funds had been discussed by, among others, the Safe Routes to School Task Force, and the process had been assumed to be easier than it had turned out to be. He added that it had taken some iterations to come up with something reasonable.

Federal Glover preferred a better process although he recognized what was available. He urged staff to be aggressive to make sure that the funds were spent in Brentwood and if that could not be done, suggested the challenge be given to 511 Contra Costa to come up with some creative or innovative program to use the funds within the East County region.

When asked what 511 Contra Costa was prepared to do in the process, Corinne Dutra-Roberts, Senior Transportation Analyst with 511 Contra Costa, expressed the hope to use the funds for capital projects. Since they already worked with school funds in Contra Costa County, she stated they could use those funds for Peace on the Streets in Contra Costa County, which had been piloted in three middle schools and which had been well received. She added that they were ready to do that starting in Central and East County.

Kevin Romick verified that 511 Contra Costa was ready to take on that roll to use the money in Contra Costa County.

Ms. Dutra-Roberts explained that would require a serious ramp up of staff to serve all of the communities and the schools in East County, particularly since they had never been blessed with that much money this fast, and if there was nowhere else to spend the funds they could spend it in Eastern Contra Costa County within the three-year window.

Steve Kersevan, City of Brentwood Traffic Manager, responded to the issue of the CMAQ funding and explained that the concentration of the Brentwood projects was on air quality. He noted that American Avenue served a middle school and a high school and suggested that a traffic signal would offer less congestion and less idling. The school was now paying for a crossing guard and with a signal that would not be required. He stated that the City current owned the right-of-way, was ready to proceed, and had the matching funds from those involved. He advised that there were six sets of existing in-pavement crossing lights at Bristol Middle School, Krey Elementary School, and at Marsh Creek Elementary. The projects were ready to proceed, and while not specifically waiting for the subject criteria whenever a grant funding opportunity came up they were ready to apply. He suggested that the project would meet the guidelines.

Chair Kalinowski verified that Mr. Kersevan would have to verify that conformance with the grant manager and suggested that if the grant manager did not confirm compliance the funding could be diverted to 511 Contra Costa. He supported a 511 Contra Costa involvement if the Brentwood project did not conform.

As to what the TRANSPLAN TAC would have to discuss, Mr. Cunningham stated that the conversations had just taken place in the last few days and the issues had not yet been resolved. There was a desire to get the projects funded in the TRANSPLAN region with a project fully capable of being funded. He added that there was no opportunity to come up with another recommendation within the timeframe involved.

On motion by Federal Glover, seconded by Jim Frazier, TRANSPLAN Committee members unanimously recommended the approach of using Safe Routes to School Funding to fund a Brentwood Project which included a traffic signal on American Avenue at Heritage High School, replacement of 66 existing solar powered in-pavement crosswalk lights, and a sidewalk gap closure project adjacent to Marsh Creek Elementary School, and if that approach failed that the funding should be diverted to 511 Contra Costa for use in East County.

RECEIVE UPDATE: STATE ROUTE 4 INTEGRATED CORRIDOR ANALYSIS

Mr. Cunningham advised that the State Route 4 Integrated Corridor Analysis was a placeholder and that the consultant was still receiving information from local groups. He expected information from the consultant next month.

TRANSPLAN BUDGET

A. <u>ADOPT 2011/2012 WORK PROGRAM AND BUDGET AND ADVISE AS APPROPRIATE</u>

Mr. Cunningham referred to his memorandum to the Committee dated May 4, 2011 and explained that most of the work program items were standing items that carried over from year to year. He characterized the work as consistent and explained that most items were He referred to the three highlighted items in the memo: driven by the CCTA. Review/Revise Administrative Procedures; Continued State Route 4 Corridor Management Planning: and Concord Naval Weapons Station (CNWS)/Los Medanos Area He stated that the item related to Administrative Procedures was to accommodate any issues that may arise, referring specifically to compliance issues. He recommended setting up steps by which any compliance issues may be administered by the TRANSPLAN Committee. He explained that the State Route 4 Corridor Management Planning item was ongoing. With respect to the CNWS, he reported that the final environmental document and General Plan Amendment was not anticipated until summer 2011. He added that the TRANSPLAN TAC had reviewed the items and had no comment.

Chair Kalinowski referred to the Administrative Procedures item, shown as Task 9 in the Draft Work Program, and recommended that the item become a study session between the TRANSPLAN TAC and the Board to work cooperatively at the same time and the same place. The Board agreed.

On motion by Bob Taylor, seconded by Jim Frazier, TRANSPLAN Committee members unanimously adopted the Work Program and Budget for 2011/2012.

B. RECEIVE REPORT ON 2010/2011 BUDGET

Mr. Cunningham reported that the budget was unchanged from last year. The TRANSPLAN TAC had no comments.

Jim Frazier asked if unanticipated expenses were being tracked, reported by Mr. Cunningham that the unanticipated expenses on compliance issues were being tracked separately.

Mr. Cunningham advised that the past two years the TRANSPLAN Budget had come in under budget although this year he anticipated coming in over budget given the compliance issues. He had no details at this point but would return at a future meeting and report. Based on prior direction from the TRANSPLAN Committee, he would take over budget figures off the next year's budget. He anticipated an additional cost in the invoice for future years given the over budget situation. He advised that no action was required on the item at this time.

RECEIVE REPORT ON eBART PROJECT (HILLCREST STATION DESIGN) AND TAKE ACTION AS APPROPRIATE

Mr. Cunningham stated that the item was a placeholder. He had a report from the City of Antioch and BART staff that discussions were ongoing and productive. He would report back at the June meeting.

<u>2011 REVIEW MEASURE J STRATEGIC PLAN UPDATE – ACTION TO</u> DETERMINE:

Mr. Cunningham advised that the CCTA updated the Strategic Plan every two years to revisit assumptions related to revenue and inflation, and to ensure project commitments did not exceed projected Measure J revenues. The item had been submitted on an amended agenda and had been included on the TRANSPLAN Committee website. For background purposes, he referred to a letter dated September 16, 2009 he had submitted to Robert McCleary, Executive Director of the CCTA regarding actions and discussions from the September 10, 2009 TRANSPLAN meeting when program money had been shifted to capital projects.

Hisham Noeimi, the CCTA's Engineering Manager, explained that in February 2011, the CCTA had approved the revenue projections for use in the 2011 Measure J Strategic Plan. He noted that the last Strategic Plan had been adopted by the CCTA in December 2009. He announced that the CCTA would be able to meet the eBART funding commitment and would be able to accelerate it to meet the project schedule. As such, the project cash flow needs for eBART were available. He added that programs would not be affected given the savings in the Highway 4 projects even though revenues were still on the decline; 4 percent lower than the last Strategic Plan.

Mr. Noeimi noted that Measure J had been approved in November 2004, extending the half cent transportation sales tax for 25 years to March 31, 2034. It was originally projected to generate \$2 billion in sales tax revenues for transportation projects and programs, and assign funding for specific projects in the Expenditure Plan based on a projected 2020 population.

Mr. Noeimi identified the projects in the Expenditure Plan where each subregion had a specific list of projects. Forty one percent of the Expenditure Plan was for capital projects and 60 percent was for programs. Projects and programs had been differentiated given that programs had a fixed rate of sales tax revenues with fixed percentages, where capital projects had fixed dollar amounts. He noted that there was no line item for project financing or contingency for revenue reductions. The Expenditure Plan did not identify which projects to do first or how to finance them, it was a blueprint for delivering Measure J capital projects and anticipated funding needs and availability for the next five years through a "Program of Projects," and the Authority used the Program of Projects to appropriate Measure J funds to capital projects.

Mr. Noeimi explained that the first Strategic Plan had been adopted by the CCTA in 2007 prior to the recession when \$2 billion in revenues had been anticipated. The CCTA expected to issue three bonds. Because the last bond was dedicated for eBART, East County had agreed not to compete for State Transportation Improvement Program (STIP) funds for five cycles. Because there was no line item to finance the projects, a 90 percent cap had been proposed on funding for the capital projects with a 10 percent leftover to be used for the debt service on proposed bonds. He reported that in 2009, the expected \$2 billion in revenues had dropped 23 percent and revenue was estimated at \$1.55 billion as a result. The actual revenues in 2010 and currently in 2011 were also less than anticipated. As a result in February the revenue projections had been lowered to \$1.5 billion over the life of the measure. He described the CCTA's bonding capacity and explained that based on an analysis with its financial advisors, the CCTA could afford to issue two additional bonds; \$222 million planned for FY 2012, and \$67 million in an eBART-specific bond planned for FY 2014.

With respect to expenditure caps, Mr. Noeimi reported that the 23 percent drop in revenue in 2008 and 2009 along with higher debt service costs on proposed bonds and a swap termination cost required a lowered cap from 90 percent to 66 percent in the 2009 Strategic Plan. With the Strategic Plan revenue projections being lowered, the cap would also have to be lowered. He noted that the Highway 4 project would be able to absorb the reduction in funding given the cost savings. The new Strategic Plan would further reduce the 66 percent cap to 62 percent.

Mr. Noeimi noted the policy to exclude East County from five STIP cycles which had been reduced to one STIP cycle in the last Strategic Plan and which would exclude East County from three STIP cycles in the current Strategic Plan. He advised that the latest Strategic Plan would be finalized by July or August 2011.

Jim Frazier verified with Mr. Noeimi that the savings associated with the Highway 4 Widening Project would remain in East County.

Mr. Noeimi clarified the funds involved and identified the projects that had been sacrificed to forward the eBART Project.

<u>ADJOURNMENT</u>

Chair Kalinowski adjourned the TRANSPLAN Committee meeting at 7:36 P.M., to June 9, 2011 at 6:30 P.M. or other day/time as deemed appropriate by the Committee.

Transportation Planning Committees (RTPCs), and items of interest

At its May 18, 2011 meeting, the Authority discussed the following items, which may be of interest to the Regional Transportation Planning Committees:

- 1. State Route 4 Widening Project Somersville Road to SR160 (Project 1407/3001): Segment 2 (Project 1407/3001) Letter of No Prejudice. Staff requests approval to amend the Letter of No Prejudice (LONP) request for Segment 2 from the \$22.984 million approved by the Authority on March 16, 2011, to a revised amount up to \$29.284 million, an increase of \$6.3 million. The Authority approved Resolution 11-07-P, Rev. 1, and authorized the Executive Director to submit the LONP request to the CTC. (Resolution 11-07-P, Rev. 1)
- 2. State Transportation Improvement Program (STIP)

2010 STIP & STIP Transportation Enhancement (TE) Projects Delivery. Staff provided the APC with an overview of the STIP projects status and delivery, and discussed alternative strategies for monitoring and delivery of projects. Staff recommended improved reporting on STIP project delivery, including quarterly reports by project sponsors to the Authority in addition to monthly reports to the TCC. Staff will defer a recommendation on changes to the approach for programming STIP-Transportation Enhancement projects pending additional discussions with the TCC, MTC and other CMAs, and review of Operations and Maintenance funding commitment prior to programming future STIP funds to projects. The Authority also approved support of sponsor's allocation extension requests and a "watch" approach for the Hercules Rail Station project.

The Board accepted the report and directed staff to prioritize Measure J projects for the 2012 STIP.*

- 3. Authorize Allocation of \$2.47 Million in Funding Through MTC's Safe Routes to School Program to the Regional Transportation Planning Committees (RTPCs), and Authorize Authority Staff to Submit the General Program and Project Descriptions to MTC for Amendment into the 2011 TIP. In April, the Authority adopted an approach to allocating the \$2.47 million in federal CMAQ funds available to Contra Costa through MTC's Safe Routes to School (SR2S) program. This approach allocates these funds among the subregions and asks the RTPCs to identify programs and projects that meet federal and MTC requirements. Each RTPC has developed a conceptual framework for programs and projects that are eligible for federal funding. Staff seeks Authority authorization for staff to enter these general program and project descriptions into MTC's Fund Management System (FMS) for amendment into the 2011 Transportation Improvement Program (TIP). The Authority authorized allocation of \$2.47 million in federal SR2S funding to the RTPCs, and authorized staff to enter the general program and project descriptions into MTC's FMS by the May 26 deadline for TIP Amendment 11-09.
- 4. Transmittal of Recommended Project List to MTC for Inclusion in the 2013 Regional Transportation Plan (RTP). In response to the 2013 Regional Transportation Plan (RTP) Call for Projects issued by MTC on February 14, 2011, Authority staff has worked with the RTPCs and project proponents to develop a comprehensive list of projects for submittal to MTC. To receive future State or federal funding, a project must first be included in the RTP. Projects that impact the capacity of the transportation system must be listed separately in the RTP. The RTP also includes programmatic categories for projects that do not impact the capacity of the transportation system (e.g. pavement rehabilitation, safety projects, pedestrian/bicycle enhancement projects, etc.). The Authority approved Resolution 11-18-G authorizing the submittal of the proposed 2013 RTP project lists to MTC for inclusion in the RTP. (Resolution 11-18-G)
- 5. Comments on the Notice of Preparation (NOP) for a Draft Environmental Impact Report on the Proposed New Farm Project. On April 26, 2011, the Contra Costa County Department of Conservation and Development (DCD) released an NOP for the New Farm Project, which is located in Tassajara Valley outside of the County's adopted Urban Limit Line (ULL). At its meeting on May 4th, the Planning Committee reviewed the NOP under Agenda Item 8.1 Correspondence, and directed staff to prepare a draft comment letter for review by the full Board. The Authority reviewed the draft comment letter and authorized changes to the letter as outlined by staff, and authorized transmittal of the letter to the County prior to the May 26 deadline for comments.

In response to the Call for Projects issued by MTC on February 14, 2011, the Authority is pleased to transmit to you its proposed lists of projects for inclusion in the 2013 RTP. At its regular meeting on May 18, 2011, the Authority adopted the attached Resolution 11-18-G, which clearly sets forth the Authority's project priorities for the Committed, Financially Constrained, and Vision Elements of the RTP Update.

Projects that already have committed funds or are 100% locally funded are listed for inclusion in the "Committed" project list, which totals \$2.2 billion in project costs. The financially constrained list includes a total of \$714 million in STIP-RIP funds, and \$114 million in STIP-ITIP funding, with project costs totaling \$1.4 billion in escalated dollars. Staff further recommends \$3.6 billion in additional projects for the Vision Element of the RTP.

In parallel with this transmittal, we have also updated MTC's projects database to reflect the current scope, schedule, and budget for each project. Updates to the project list database were completed by Authority staff on May 6, 2011.

In response to MTC's request, the Authority convened a series of public meetings through its four Regional Transportation Planning Committees (RTPCs), whose members include elected officials from each local jurisdictions in Contra Costa.

To kick off the outreach process, early on we videotaped the "expanded" TRANSPAC meeting which covered the 2013 RTP and SCS process. This meeting was held in Walnut Creek on January 31, 2011, at 6:30 p.m., and had over 50 attendees. Subsequently, CCTV broadcast the video of that meeting several times during February and March.

Members of the public, city staff, the transit operators, and Caltrans participated in public discussions held throughout the county as shown in the attached schedule. Each of these meetings was open to the public and was noticed in accordance with the Brown Act. We also brought the "call for projects" discussion to the Authority's Citizen's Advisory Committee, and the Technical Coordinating Committee.

To gain further input from Contra Costa's citizenry, a workshop was held in San Pablo on April 13, 2011 at 6:30 p.m. The following week, a Public Hearing was held at the Authority offices in Walnut Creek on April 20, 2011 at 6:00 p.m.

Meeting notifications were transmitted through an expanded e-mail listing of 1,600 persons.

Throughout the process, the Authority used its website to post updated status reports regarding the project lists. Each time new information became available regarding the project lists, this information was posted on the website. Furthermore, information regarding the Authority's public outreach effort was posted on OneBayArea.org, and on other regional and local websites.

We trust that this effort fulfills MTC's request that the CMAs conduct the outreach effort for this process.

RESOLUTION 11-18-G

RE: Adoption of the Contra Costa Transportation Authority's Proposed 2013 Transportation Plan (RTP)
Projects Lists for Submittal to MTC

WHEREAS, the Contra Costa Transportation Authority (the "Authority") has been designated as the Congestion Management Agency (CMA) by the cities, towns and County of Contra Costa; and

WHEREAS, under the provisions of Sections 65082 (b) and 65088.5 (b) the Metropolitan Transportation Commission (MTC) is required to incorporate the congestion management program (CMP) in the Regional Transportation Improvement Program (RTIP) submitted biennially to the California Transportation Commission (CTC) for state and federal transportation funding in the State Transportation Improvement Program (STIP), unless the CMP is inconsistent with the Regional Transportation Plan; and

WHEREAS, on February 14, 2011, MTC requested that all of the CMAs submit project lists totaling approximately \$32 billion for the Bay Area, with Contra Costa's estimated population-based share at \$4.48 billion (escalated); and

WHEREAS, under Section 188.8 of the Streets and Highways Code "county share" funds are allocated by the CTC according to formula, and are required to be spent in each county as part of the STIP; and

WHEREAS, the Measure C Sales Tax Renewal Ordinance (# 88-01 as amended by # 04-02), herein referred to as "Measure J", approved by the voters in November 2004, allocates \$2 billion in 2004 dollars to new transportation investments, including more than \$800 million for various projects; and

WHEREAS, building upon the June 2003 report, "Shaping Our Future", the cities, towns and County have been working cooperatively with ABAG and MTC to better link land use and transportation, with many jurisdictions far along in developing specific plans or implementation of transit-oriented and/or dense mixed use development; and

WHEREAS, to achieve the broad, multi-modal vision approved by the voters with the passage of Measure J, the Authority will need to match its local sales tax funds with its county share and funds from a variety of other sources; and

WHEREAS, the Authority supports the broad goals of the 2013 RTP, and believes that the best way to accomplish those goals is for the Authority to work collaboratively with other CMAs, Caltrans and MTC to manage corridor congestion; better link transportation and land use; and provide effective transportation facilities and services that enhance mobility in an environmentally sensitive manner; and

WHEREAS, the Authority is committed to working collaboratively with MTC through the Bay Area Partnership to address AB 32 and SB375, and has taken significant strides in that direction, through adoption of the Measure J Growth Management Program, which includes a requirement for each local jurisdiction to

adopt a voter approved Urban Limit Line, and through its participation in the Sustainable Communities Strategy; and

WHEREAS, during February, March, and April of 2011, the Authority conducted an extensive public outreach process in accordance with MTC's Public Outreach Plan, including numerous RTPC meetings, one workshop, and a public hearing to solicit input on projects and programs for submittal to MTC; and

WHEREAS, the Authority has developed its projects and programs to respond to and respect the diversity, uniqueness and varying needs of each part of Contra Costa County, and recognizes the eight other Bay Area counties have their own diverse characteristics and needs; and

WHEREAS, Contra Costa is the third largest county by population in the region, is slated to absorb the third largest increase in population after Santa Clara and Alameda, and has provided a disproportionately higher share of affordable and workforce housing in the Bay Area in the past 25 years;

NOW, THEREFORE, BE IT RESOLVED, THAT IN RESPONSE TO MTC'S FEBRUARY 14, 2011 REQUEST FOR SUBMITTAL OF PROJECTS, THE AUTHORITY HEREBY:

- (1) Adopts the attached capital project lists as shown in Exhibits 1, 2, and 3, for incorporation into the Draft 2009 RTP as follows:
 - Exhibit 1: Proposed "Committed" Project List;
 - Exhibit 2: Proposed "Financially Constrained" Project List; and
 - Exhibit 3: Proposed "Vision Element" Project List.
- (2) Finds that Exhibits 1 and 2 constitute the Authority's core project lists for incorporation into the Draft 2013 RTP to best fulfill the mandate of the voters, balance Contra Costa's diverse needs with constrained STIP funding, and to address the goals set by MTC as part of the 2013 RTP process.
- (3) Should MTC's fund estimate for the financially constrained element of the RTP result in higher revenues than estimated herein, recommends reconsideration in collaboration with the Authority of the projects recommended in the "Vision Element" Project List (Exhibit 3), for inclusion in the financially constrained element (Exhibit 2). Such projects should be modeled in a way that would make them eligible for future discretionary funding as part of the RTP's environmental impact report (EIR).



I am pleased to submit the California Department of Transportation's (Department) recommendations for the Corridor Mobility Improvement Account (CMIA) savings as directed by your Project Coast Savings Call for projects item at the March 2011 California Transportation Commission (Commission) meeting. Assuming adequate savings are available, I recommend programming the eight projects as shown in Tier 1 categories in the attached project list for the June Commission meeting.

Overall, the Department received thirty-seven project applications requesting slightly over one billion dollars of new CMIA funding. All applications were received on time and in accordance with your instructions, except for two applications, both of which were late. Additionally, one of the two late applications was not delivered to the Department in accordance with your instructions.

The Department examined each project application for completeness, accuracy, and consistency with Commission Guidelines. As directed by your Project Coast Savings Call for Projects, the attachment ranks projects in priority order, which the Department has met the goals and requirements of the CMIA program. As noted in CMIA Guidelines, these goals are to provide demonstrable congestion relief, enhanced mobility, improved safety, and stronger connectivity to benefit traveling Californians.

When developing our recommendations, the Department weighed delivery, consistency with guidelines and requirements, goals of the CMIA program, and regional diversity. The eight projects prioritized under Tier 1, four in the north and four in the south, are the earliest deliverable projects that are unquestionably consistent with guidelines and CMIA goals.

Projects that appear to be ready for construction the fall of 2012 or later were given a lesser priority. Projects that propose to replace local or state funds with CMIA savings, projects not programmed in the initial 2007 adopted program, and projects found not to enhance the benefits of programmed CMIA projects were deemed ineligible.

Dear Mr. Iwasaki:

At the May 2, 2011 Southwest Area Transportation Committee (SWAT) meeting, the following issues were discussed that may be of interest to the Authority:

Consider and Recommend Safe Routes to School (SR2S) Funding Approach for the SWAT Subregion: SWAT discussed extensively their options for utilizing its share of CMAQ SR2S funds within the southwest region. After substantial discussion, the SWAT Committee unanimously adopted the following:

- 1. A combined project-and-program approach, whereby:
 - a. The Lamorinda jurisdictions' funds, with contributions from Danville and San Ramon's share of SR2S funding, would be used to deliver a "bundled" capital project:
 - b. The South County jurisdictions' funds (Contra Costa County and the remainder of Danville and San Ramon's SR2S funds) would be used to extend the life of the existing SR2S Program.
- 2. Direction for the SWAT TAC to reconvene with the appropriate engineering colleagues to determine the most feasible path for implementing a multi-jurisdictional "bundled project." If the "bundled project" approach is determined to be infeasible, identify another approach for equitably expending these CMAQ funds within SWAT (with future subregional quid pro quo, as necessary); and
- 3. Request that the CCTA consider appropriating the funds currently set-aside for the latter phases of the SR2S Master Plan [or other funds as appropriate] to help cover some or all of the costs of administering a multi-jurisdictional "bundled project."

Other relevant and important elements of SWAT's discussion included acknowledgement on the part of SWAT jurisdictions that participation in the "bundled project" approach requires acceptance of a "forfeiture" element, whereby a jurisdiction who could not meet the strict MTC and Caltrans timeframes would forfeit their share of the SR2S funds to the remaining projects in order to avoid jeopardizing the entire "project bundle".

STATE ROUTE 4 WIDENING

A. SR4 Widening: Railroad Avenue to Loveridge Road – No Changes From Last Month Lead Agency: CCTA

Project Description: The project widened the existing highway from two to four lanes in each direction (including HOV lanes) from approximately one mile west of Railroad Avenue to approximately ³/₄ mile west of Loveridge Road and provided a median for future transit.

Current Project Phase: Highway Landscaping – Plant Establishment Period

Project Status: Landscaping of the freeway mainline started in December 2009 and was completed in June 2010. A three-year plant establishment and maintenance period is currently in progress as required by the Cooperative Agreement with Caltrans.

Issues/Areas of Concern: None.

B. SR4 Widening: Loveridge Road to Somersville Road

Lead Agency: CCTA

Project Description: The project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) between Loveridge Road and Somersville Road. The project provides a median for future mass transit. The environmental document also addresses future widening to SR 160.

Current Project Phase: SR4 mainline construction.

Project Status: Construction of the SR4 mainline and Loveridge Road widening began in June 2010. It is estimated that the project construction will be completed in late 2013 or early 2014 depending on weather and the contractor's approved working schedule. The construction staging and duration is significantly affected by environmental permit restrictions associated with existing creeks and waterways within the project limits.

Current construction activities include drainage facilities, retaining walls, sound walls, foundation work for the new SR 4 bridge over Century Boulevard, and foundation work for the new southbound Loveridge Road bridge over SR 4. Concrete paving activities for new westbound freeway lanes east of Century Boulevard are also proceeding <u>After the exterior portions of the new concrete freeway lanes east of Century Boulevard are complete, traffic will be switched onto the newly paved sections of roadway east of Century Boulevard to allow construction of the new interior portions of the freeway</u>

east of Century Boulevard. The eastern end of the freeway for this project is being completed to allow access for the next contractor to begin work on the adjacent SR4/Somersville Road Interchange Project. Century Boulevard at SR 4 is closed for two months for new bridge construction. It is estimated to reopened in early August 2011.

The project construction is approximately <u>23%</u> complete.

Issues/Areas of Concern: none

C. SR4 Widening: Somersville Road to SR 160

Lead Agency: CCTA

Project Description: This project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) from Somersville Road to Hillcrest Avenue and then six lanes to SR 160, including a wide median for transit. The project also includes the reconstruction of the Somersville Road Interchange, Contra Loma/L Street Interchange, G Street Overcrossing, Lone Tree Way/A Street Interchange, Cavallo Undercrossing and the Hillcrest Avenue Interchange.

Current Project Phase: Segment 1 Somersville Interchange: Construction Phase; Segments 2, 3A and 3B: Right of Way Acquisition, Utility Relocation & Final Design Phase

Project Status: The project is divided into four segments: 1) Somersville Interchange; 2) Contra Loma Interchange and G Street Overcrossing; 3A) A Street Interchange and Cavallo Undercrossing and 3B) Hillcrest Avenue to Route 160.

<u>Segment 1:</u> The project was advertised for construction bids on July 19, 2010, bids were opened on October 5, 2010 and Caltrans awarded the contract on December 23, 2010. 2010. The formal preconstruction meeting with the contractor, construction management team, and various stakeholders occurred on February 23, 2011. The first contractual working day for the project was March 16, 2011. <u>The Project Partnering Meeting was held on March 16, 2011. There are 550 working days allowed for this contract to be completed.</u>

Permit (WDID) has not occurred as of May 4, 2011. However, since the review period has now
exceeded the allowable 30 days timeframe for the Board's official review and there has been no
response to date, Caltrans has permitted the contractor to proceed while awaiting final comments and
WDID Number. Construction activities performed to date include the installation of construction area
signs, placement of temporary barrier (K-Rail), temporary roadway re-striping, mobilization of
contractor's equipment and other miscellaneous startup and Staging activities. In addition, work has
begun on the Retaining Walls along the east side of Somersville Road south of SR4 to meet Temporary
Construction Easement requirements. Two test panels of the architectural treatment (Delta Region
Native Landscapes) that will be cast into various retaining walls throughout the Project, have been
completed and submitted to Caltrans for review and approval. Test panel 2 met the required criteria and
will be acceptable to Caltrans with some corrections noted.

<u>Segment 2:</u> Caltrans District 4 approved the PS&E documents and sent it to Caltrans HQ on March 16, 2011 for final review and advertisement. Ready-to-list (RTL) is targeted for May 2011, pending HQ's review schedule. Advertisement for construction bids is targeted for <u>July 11, 2011.</u>

Segment 3A: <u>TY Lin is working on preparation of Final PS&E documents, targeted to be submitted to Caltrans District 4 this month, May 2011. The RTL date for this segment is targeted for September 2011 with advertisement for construction bids in November 2011, pending availability of State funds.</u>

Segment 3B: This segment, Hillcrest Interchange area, was delayed due to coordination issues related to the future eBART station and geometric approval by Caltrans of the proposed Hillcrest Interchange. Currently, TY Lin is proceeding with the 65% PS&E documents and the team is revising the project delivery schedule for this segment, with a targeted RTL date of May 2012. The Authority will advertise, award and administer the construction contract for this segment.

Issues/Areas of Concern: Availability of all fund sources in time to meet the project delivery schedule continues to be a concern for this corridor project. In March 2011 the Authority provided approval for staff to submit a Letter of No Prejudice (LONP) to authorize expenditure of Measure J funds in lieu of Proposition 1B funds programmed for Segment 2 construction. If availability of STATE funds continues to be delayed, construction of the follow on Segments (3A & 3B) will be compromised. The delay of the freeway project will affect construction of eBART, which will run in the newly constructed median of SR4.

STATE ROUTE 4 BYPASS PROJECT

Segment 1

Right-of-way acquisition is complete. The acquisition of the final parcel, the Contra Costa County Flood Control Department parcel, was completed in February 2011. Construction has been completed and closed out.

Segment 2

Current activities on Segment 2 are being funded with Measure J funds and are presented below by phase.

Sand Creek Interchange Phase I Stage I - Intersection Lowering Project (Construction /CM) The project has been completed and closed out.

Sand Creek Interchange Phase I, Stage 2 - Final Design

The project has been submitted for CMIA funding. Design is essentially complete and the schedule is presented below. Randell H. Iwasaki, Executive Director The Metropolitan Transportation Commission (MTC) and the California Department of Transportation (Caltrans) are pursuing development of an integrated Bay Area express lane network to enhance mobility, increase system utilization and afford greater user flexibility over the transportation network within the San Francisco Bay Area. MTC and Caltrans are seeking support from the Contra Costa Transportation Authority (CCTA) in this endeavor.

High-Occupancy Vehicle (HOV) lanes promote carpooling and public transit since the traffic speed in HOV lanes is usually greater when compared to adjacent mixed-flow lanes, particularly during peak travel periods. However, HOV lanes are often criticized because many are underused. Express lanes (also referred to as High Occupancy Toll, or HOT lanes) allow single-occupant vehicles to pay a toll for the privilege of using excess capacity in HOV lanes. Carpools and transit continue to use the express lanes for free. Express lanes require single-occupant vehicles to pay a toll that varies based on demand, called congestion pricing. The tolling algorithm uses real-time traffic conditions to manage the number of single occupant vehicles that use the express lanes. Express lanes must remain free of congestion, even during rush hour, to not discourage carpools and public transit.

Express lanes provide an option for commuters and non-routine drivers to pay to get through traffic quickly. A routine commuter who left home late for work, a family wanting to catch a flight, or a plumber trying to get to his customer quickly may come out ahead financially from using the express lane. Drivers who do not utilize express lanes can also benefit. Express lanes take traffic out of the mixed-flow lanes, in contrast to the sometimes underutilized HOV lanes. Funds raised from express lanes are used to pay for the maintenance and operations of the lane(s), payment of debt for the initial construction of the lane(s) and to build out the express lane network. Any remaining funds can also be used to support transit service in the corridors.

2999 Oak Road Suite 100 Walnut Creek CA 94597 PHONE: 925.256.4700 FAX: 925.256.4701 www.ccta.net California Streets and Highways Code Section 149.7 (enacted under AB 1467, 2006), allows the California Transportation Commission (CTC) to authorize, until December 31, 2011, two express lane facilities in Northern California. MTC plans to submit an application to the CTC that authorizes an approximately 535-lane mile backbone network representing a subset of the full 800-lane mile network commitment included in MTC's long-range *Transportation 2035 Plan*. Existing and planned HOV lanes will be converted to or constructed as express lanes. The backbone express lane network as a whole will be defined as a single project in the application to the CTC. The network will be built in segments based on future environmental studies, project readiness and funding and financing constraints. The application will likely define a phased implementation approach spanning the next 20 to 30 years. Refer to the attachment for a map of the proposed backbone network.

MTC's 2002 HOV Master Plan and CCTA's investment decisions support HOV lanes as a means to improve travel times and reduce emissions. However, the HOV lane system is characterized by gaps, limiting travel time savings for carpoolers and express buses. Closing gaps in the existing HOV system improves reliability of express buses and other transit options that use HOV lanes. Converting HOV lanes to express lanes optimizes capacity on Bay Area freeway corridors to meet current and forecast traffic demands, and provides a funding mechanism to accelerate the closure of HOV gaps in the existing system. Benefits of the proposed express lane network include:

- Reductions in congestion and emissions by making more efficient use of the freeway infrastructure;
- Providing a reliable travel option for express bus and carpools via the HOV network and use of
 excess capacity in the express lanes for those who choose to pay the toll;
- Completing the HOV/HOT network ten to forty years sooner than if relying upon traditional state and local funding mechanisms.

The proposed Bay Area express lane backbone network includes the full length of I-80 and I-680 in Contra Costa. The recently opened northbound HOV extension on I-80 provides for continuous HOV lanes in both direction of I-80 from the Carquinez Bridge to the Bay Bridge toll plaza. I-80 is unique in the Bay Area in that it is the only corridor (exclusive of toll bridges) that requires 3 or more occupants to legally use the HOV lane. Even with this constraint, the I-80 HOV lanes are heavily utilized resulting in limited excess capacity available for express lanes, especially south of the I-80 / SR 4 interchange. The phasing approach in the MTC application will likely place I-80 in Contra Costa and Alameda counties in later phases. Improved traffic conditions and new technologies are necessary before serious consideration can be given to express lanes on this corridor.

Preliminary analysis from the MTC consulting team suggests that I-680 in Contra Costa is a strong candidate for express lanes in that costs to implement are relatively low. Initial revenue projections are

not yet complete but are expected before the MTC submits its application to the CTC. The CCTA is sponsoring a project to close the southbound HOV gap through Walnut Creek, thus creating a continuous HOV lane from Marina Vista Avenue in Martinez to Alcosta Boulevard near the Alameda County line. A contract was recently awarded to begin the environmental clearance phase, however, funding to construct the HOV gap closure has not been identified. The MTC application currently assumes a gap in the northbound HOV lane at the I-680 / SR 24 interchange. CCTA staff will investigate closing this gap as part of the southbound HOV project. The only other missing segments of HOV lanes are northbound between North Main and SR 242, and between the Benicia-Martinez Bridge and Marina Vista Avenue. If authorized by the CTC through the MTC application, and subsequently by the CCTA Board, the consultant contract could be amended to include additional environmental considerations and traffic and revenue studies to confirm the feasibility of express lanes on I-680.

MTC and Caltrans have developed a Draft Project Study Report and portions of the Draft Application. CCTA staff have been actively engaged with MTC and Caltrans in scoping of the backbone network and considerations for future operations of a completed network. MTC plans to submit the final draft application to CTC staff in August 2011 for their review. CTC Guidelines require the demonstration of local support to be submitted concurrently with the application. MTC is seeking letters of support from the each Congestion Management Agency, including CCTA.

Comments from CTC staff and its advisors are expected to be addressed at the September CTC meeting. The current schedule has CTC approval of the express lane network in October 2011. If necessary, CTC action could occur as late as December 2011 (CTC does not meet in November this year).

CCTA staff plan to discuss express lanes and the most up-to-date information regarding the MTC application with each Regional Transportation Planning Committee in June. Staff requests to be placed on the TRANSPLAN agenda on June 9, 2011. The matter will be discussed at the July 7, 2011 Administration and Planning Committee. I plan to ask the CCTA Board to consider a letter of support at its July 20, 2011 meeting.
