December 14, 2023

The regular meeting of the TRANSPLAN Committee was convened as an in-person meeting with the option for members of the public to appear in person or to participate via Zoom teleconference. Persons who wished to address the Board during public comment or with respect to an item on the agenda were able to comment in person or call in or log in to the meeting via Zoom.

Chair Shanelle Scales-Preston convened the meeting at 6:34 P.M.

PUBLIC COMMENTS

BRUCE 'OLE' OHLSON, Pittsburg, noted the item under Consent related to major East County transportation projects and referred to the Mokelumne Trail Bike/Pedestrian Overcrossing project that he understood would not be completed until mid-April 2024. He also referred to Highway 4 between the Willow Pass Road Interchange and the Port Chicago Highway Interchange and noted the Contra Costa Transportation Authority (CCTA) was the lead agency and had reported that the project was on hold pending the availability of funds, although he had also learned from Caltrans that construction could not begin until bicycles were off that segment of the freeway given that the Delta de Anza Regional Trail was currently at the edge of the Concord Naval Weapons Station (CNWS). Related to that situation was that the only other alternative to the freeway for bicycles was Willow Pass Road going into Concord using the existing narrow bridge on Willow Pass Road, what he characterized as a deathtrap for anyone not in a car. He had been told that the bridge would be torn down in eight years when the adjacent housing development would begin. He emphasized that bicyclists could not wait until then. Mr. Sarmiento presented the request for a letter of support for Contra Costa County's grant application for the Caltrans Sustainable Transportation Planning Grant Program and the authorization for the Chair of the TRANSPLAN Committee to sign the letter to fund the Bay Point Enhanced Bicycle and Pedestrian Improvements Study. He advised that the draft letter had been included with the staff report and John Cunningham, project staff, was available to respond to questions from the TRANSPLAN Committee.

BRUCE 'OLE' OHLSON, Pittsburg, stated that the East Bay Regional Park District (EBRPD) had planned the Delta de Anza Regional Trail from Concord to Oakley, most of which had been completed, although a segment was missing in the former CNWS. He noted that wherever the trail was in a jurisdiction, the jurisdiction was required to supply a safe route. The trail currently stopped at the corner of Willow Pass Road and Port Chicago Highway and he suggested that the EBRPD ignored that and its trail started at the Evora Road Trail area.

Mr. Ohlson stated the County's bicycle community wanted to see a study for a Class IV path as had been planned for Port Chicago Highway and Willow Pass Road, which would be an extension to the west of Port Chicago Highway. Without such a study, bicyclists would be left on the marked shoulder and there would be no request for a safer route between Port Chicago Highway and Evora Road.

Mr. Cunningham advised that he would take a look at the jurisdictional boundaries of the areas referenced to potentially incorporate them into the scope.

Mr. Cunningham added that he did not want to take a fairly straightforward project and expand it such that it would get bogged down and not move forward. To that end, he would speak to Mr. Ohlson off-line and take a closer look at the project scope and discuss it with EBRPD representatives.

In response to Sarah Foster, Mr. Cunningham stated he was not aware of the exact federal responsibility with respect to the area of the CNWS. He noted there were federal sources for bicycle/pedestrian projects that could be researched and the search for funding could be expanded to those federal sources.

Project Description: Use state-of-the-practice Intelligent Transportation System (ITS) technologies to enhance the effectiveness of the existing transportation system along State Route 4 (SR4) and parallel/crossing arterials between SR160 and Interstate 80 (I-80). Project elements include the following:

- Operational strategies based on real-time traffic conditions along the corridor (a.k.a. Decision Support System)
- Adaptive ramp metering
- Incident management with speed harmonization
- Traffic and transit Information System
- Arterial and transit improvements
- Connected Vehicle (CV) applications/technologies
- Integration with the I-80 Integrated Corridor Management (ICM).

The SR 4 ICM may be combined with one or more packages of the SR 4 Operational Improvements (Project 6006).

Current Project Phase: Environmental Clearance

Project Status:

- Project was awarded a Federal Highway Administration (FHWA) ICM Planning Grant.
- Completed Systems Engineering Management Plan (SEMP) 2 System Requirements Concept of Operations (ConOps) report.

Project is on hold pending future funding.

STATE ROUTE 4 (FORMER "BYPASS" PROJECT)

C. SR-4: Mokelumne Trail Bike/Pedestrian Overcrossing (portion of Project #5002)

CCTA Fund Source: Measure J

Lead Agency: CCTA

Project Description: Construct a pedestrian and bicycle overcrossing near the Mokelumne Trail at SR4. The overcrossing will include a multi-span bridge with columns in the SR4 median. Bridge approaches will be constructed on earthen embankments. The path width is assumed to be 12 feet wide. This project is required as a condition of approval under the SR-4 Bypass project.

Current Phase: Construction.

Project Status:

- The CEQA clearance is complete.
- Design is complete.
- A Joint Exercise Powers Agreement (JEPA) between SR4 Bypass Authority (SR4BA), ECCRFFA, City of Brentwood and CCTA to define and establish the roles and responsibilities for the project was approved by the Authority Board in July 2020.
- The Authority awarded the construction contract to Joseph J. Albanese in September 2021.
- Groundbreaking ceremony was held on March 18, 2022.

Issues/Areas of Concern:

A design change to bring bridge slopes into compliance with the Americans with Disabilities Act (ADA) regulations is being finalized. Project completion will be impacted by this change.

Update from Previous Quarterly Report

STATE ROUTE 239 (#5007)

Study Status: Scope

State Route 239 (SR239) was first legislated in 1959 as a possible roadway linking SR4 in Brentwood to I-205 or I-580 west of Tracy. A Feasibility Study and a Project Initiation Document were completed in 2015. The current scope is to complete the preliminary engineering and environmental document (PAED) for SR239 to determine its alignment, complete the State Route Adoption process, and to identify and obtain environmentally approval for an initial segment to proceed with design and construction.

Administration: Responsibility for the State Route 239 Study the associated federal funding was transferred from Contra Costa County to the Contra Costa Transportation Authority in January 2012.

Status

- Feasibility study and project initiation document have been completed.
- The PAED work is ongoing.

Issues/Areas of Concern

- Significant funding is needed to complete project and a two-tiered process is being contemplated to be consistent with project phasing.
- The proposed hybrid programmatic and project level PAED is new to Caltrans District 4. Staff is working with Caltrans to develop and address new mandates and policies on Vehicle Miles Traveled and Climate Change. The includes transit and other transportation modes.
- COVID-19 has significantly impacted traffic movement and the project team is developing an alternative approach to conduct traffic study for the project.
- Coordination with other projects in the project area will minimize potential major conflicts.
- Project has to adapt to changing environmental protocols.

Update from Previous Quarterly Report

- Consultant is continuing with field reviews and surveys. Various environmental technical studies are <u>ongoing</u>.
- <u>Project alternatives are being updated, refined and evaluated based on coordination with other projects, public input and to minimize environmental impacts.</u>
- <u>A draft bike plan is being updated with other planned public access and trail improvements. Project includes multi-modal project elements which may include accommodation for future micro-transit.</u>
- <u>The project team is preparing studies and plan to meet SB 743 requirements to address induced</u> <u>VMT.</u>
- <u>Project schedule has been updated based on the latest information.</u>

STATE ROUTE 4 WIDENING

D. SR4 Widening: Railroad Avenue to Loveridge Road COMPLETED

Lead Agency: CCTA

Project Description: The project widened the existing highway from two to four lanes in each direction (including HOV lanes) from approximately one mile west of Railroad Avenue to approximately ³/₄ mile west of Loveridge Road and provided a median for future transit.

Current Project Phase: Completed.

Project Status: Landscaping of the freeway mainline started in December 2009 and was completed in June 2010. A three-year plant establishment and maintenance period is currently in progress as required by the Cooperative Agreement with Caltrans, was completed on June 24, 2013. Caltrans has accepted the project and will take over the maintenance responsibilities. The CCTA Board accepted the completed construction contract, approved the final contractor progress payment, approved the release of the retention funds to the contractor, and authorized staff to close construction Contract No. 241 at its September 18, 2013 meeting.

Issues/Areas of Concern: None.

E. SR4 Widening: Loveridge Road to Somersville Road COMPLETED

Lead Agency: CCTA

Project Description: The project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) between Loveridge Road and Somersville Road. The project provides a median for future mass transit. The environmental document also addresses future widening to SR 160.

Current Project Phase: Completed.

Project Status: Caltrans accepted the contract on June 30, 2014. The construction contract is now closed with no outstanding claims.

Issues/Areas of Concern: None.

F. SR4 Widening: Somersville Road to SR 160 COMPLETED

Lead Agency: CCTA

Project Description: This project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) from Somersville Road to Hillcrest Avenue (plus auxiliary lanes), including a wide median for transit, and then six lanes to SR160 and the new SR4 Bypass.

The project was constructed in five segments:

- Segment 1: Somersville Road to Contra Loma Boulevard.
- Segment 2: Contra Loma Boulevard to A Street/Lone Tree Way.
- Segment 3A: A Street/Lone Tree Way to Hillcrest Avenue.
- Segment 3B: Hillcrest Avenue to SR160.
- Corridor-wide: Landscaping.

Current Project Phase: Completed.

Project Status: The project is divided into four segments: 1) Somersville Interchange; 2) Contra Loma Interchange and G Street Overcrossing; 3A) A Street Interchange and Cavallo Undercrossing and 3B) Hillcrest Avenue to Route 160.

- 2. Reviews and provides recommendations on applications for funding for bicycle and pedestrian projects and programs,
- 3. Review and comment on "complete streets" checklists required of proposed projects, and
- 4. Address other bicycle or pedestrian issues facing CCTA, Contra Costa County, and the region.

The CBPAC by-laws specify that TRANSPLAN shall have one Citizen representative, one Primary staff representative, and one Alternate staff representative on the CBPAC. The Citizen representative and Primary staff representative positions are currently filled.

The Alternate TRANSPLAN staff representative position has been vacant since the former representative, Julissa Rico-Ruiz, left the City of Pittsburg in December 2023. Khristin Labao (Pittsburg) expressed interest in being appointed as the Alternate TRANSPLAN staff representative and the TRANSPLAN TAC unanimously approved her selection at its January meeting.

Recommendation

RECEIVE update on TDM 2.0 and proposed CCTA TFCA policy and provide input.

Background

Travel Demand Management (TDM) consists of strategies and programs that aim to reduce vehicle miles traveled (VMT) and greenhouse gas emissions (GHG) through the reduction of single-occupancy vehicle use and the encouragement of alternative travel modes, such as carpooling, biking, walking, and transit.

TDM activities in Contra Costa County are funded by Measure J – Program 17 (Commute Alternatives) and TFCA, whose focus is to fund activities that reduce vehicle emissions. TFCA funds are allocated to each RTPC based on a formula that considers the population and number of jobs in each RTPC.

TDM activities in East Contra Costa County are delivered by 511 Contra Costa, under a contract administered by CCTA, with oversight by the TRANSPLAN TAC. CCTA is undertaking an effort, dubbed "TDM 2.0," to evaluate the current TDM program countywide and implement enhancements to boost program effectiveness.

With TDM 2.0, CCTA is proposing a new TFCA policy that will allocate TFCA funds to agencies in Contra Costa County based on a competitive process. The types of activities that the new TFCA policy will prioritize are bicycle and pedestrian projects, rideshare services, and first- and last-mile connections. Applications will be scored based on their ability to reduce VMT and GHG emissions. CCTA anticipates adopting the new TFCA policy later in 2024 and releasing a call for proposals soon after.

A memo from CCTA summarizing TDM 2.0 and the proposed CCTA TFCA policy is included as Attachment A.

CCTA staff presented TDM 2.0 and the proposed CCTA TFCA policy to the TRANSPLAN TAC at its January 16, 2024 meeting. TAC member comments included proposing increased funding for bicycle facilities and transit service and concerns with agency staff capacity to develop and submit TFCA grant proposals.

CCTA staff has also presented this item to the other RTPCs to gather their input. The WCCTAC Executive Director has produced a letter for the WCCTAC Board that includes comments made by WCCTAC TAC members on TDM 2.0 and the proposed CCTA TFCA policy (Attachment B).

Subject: Travel Demand Management 2.0 and CCTA Transportation Fund for Clean Air Policy

Transportation Demand Management is one of the strategic priorities of the Contra Costa Transportation Authority (Authority). The Authority desires to implement a more robust and relevant Travel Demand Management (TDM) program. The new program, branded as TDM 2.0, is envisioned to have countywide implementation, aligns with the Authority's strategic position, and incorporates performance measures in Vehicles Miles Travelled (VMT) and emission reductions.

The current TDM program includes many activities to promote alternatives to commuting in single-occupant vehicles, benefiting employers, municipalities, K-12 schools, colleges, commuters, and residents. The program activities are managed by the three offices: 1) the Authority, on behalf of TRANSPAC and TRANSPLAN, 2) SWAT, and 3) WCCTAC.

Funding for the TDM program comes from two main sources – Transportation Fund for Clean Air Policy (TFCA) and Measure J Program 17 – Commute Alternative funds. The Authority annually approves TFCA and Measure J Program 17 funds to the four county sub-regions based on a formula that includes the equity weight of population and jobs. The county total of funds for TDM program in Fiscal Year 2023-24 was approximately \$2.5 million.

To achieve the goals and objectives of TDM 2.0, Authority staff is proposing several steps to implement in the next three years:

Step 1a (FY 24-25):	Existing TDM Program Improvements
Step 1b (FY 24-25):	New Contra Costa TFCA Policy
Step 2 (FY 25-26):	TDM Strategic Plan
Step 3 (FY 26-27):	TDM 2.0 Implementation

Authority staff is planning to present a revised draft TFCA Policy to the RTPC Committee/Board meetings in February and March.

Pinole	The WCCTAC Technical Advisory Committee (TAC) was established by WCCTAC's Joint Powers Agreement and is comprised of member agency staff, generally with public works and planning expertise. Its role is to advise the Board.
Richmond	At its January 11, 2024, meeting, the TAC received a presentation from CCTA staff on the "TDM 2.0" proposal. Representatives from all nine WCCTAC member agencies were present. At the conclusion of the agenda item, TAC representatives asked
	WCCTAC staff to send a letter to the WCCTAC Board on its behalf. There were no TAC member objections to this request. Staff gathered comments from the meeting,
San Pablo	received comments from TAC representatives after the meeting, and sent a draft letter to TAC members for review. This is the final version of the TAC's letter to the Board.
	The TAC's comments are summarized as follows:
Contra Costa County	 No Time to Review and Consider – CCTA staff are proposing a major policy change to the countywide TDM program with implications for local jurisdictions, transit agencies, and WCCTAC. WCCTAC staff and the TAC first learned about the specifics of this proposal on Jan 11, 2024. The CCTA staff, however, are already initiating the approval process and plan to ask the
AC Transit	Technical Coordinating Committee (TCC) to approve these changes as early as February 2024, and the CCTA Board to approve them as early as March 2024. The proposed schedule is surprising and concerning to the TAC. It did not hear a compelling reason as to why this process needed to move so quickly.
BART	 Negative Impacts for West County – The change being proposed by CCTA is to stop using TFCA funds to support the existing countywide TDM Program and to use them instead for an annual grant program. This change could have tangible downside for cities and other WCCTAC member agencies.
WestCAT	Currently, West Contra Costa County receives guaranteed benefits from the existing TDM program which encourages and supports the use of alternative

modes. Cities, transit agencies, and WCCTAC do not need to apply for competitive grants from the Authority to receive these benefits. In fact, most West County cities have deferred the implementation of a TDM program to WCCTAC in their municipal codes. Without TFCA fund to support the countywide TDM Program, a remaining, bare-bones program would leave local jurisdictions without most of these existing services and possibly with additional responsibilities.

 Concerns about the Proposed Grant Program – The TAC also has concerns about the proposed CCTA grant program and its usefulness for WCCTAC member agencies. The amount of TFCA funds available annually (\$1.5M countywide and \$353,000 in West County) is essential to the TDM program but would make for a very small grant program if re-purposed.

Limited Member Agency Capacity

Some TAC members are concerned about their capacity to apply for grants, particularly small ones. Other TAC members stated that while they have capacity to pursue grants, they do not have the staffing to manage program activities. Still others noted that, even if they had general staffing capacity, they may not have the in-house expertise to deliver TFCA-qualifying work. This issue was of particular concern for small cities.

WCCTAC Capacity

Some TAC members stated that, if they were to receive TFCA dollars through the CCTA to implement programs activities, they would prefer to have WCCTAC manage those activities. WCCTAC staff, however, explained that it would not be able to afford to retain specialized TDM staff if it no longer receives TFCA funding from CCTA. Even if the proposed grant program makes TFCA dollars available for staffing support, WCCTAC would have no certainty from year to year about whether its grant applications, or the grant applications of its member agencies, would be accepted.

Delivery and Administration Concerns

The TAC also expressed concern about the potential inefficiencies in program delivery under the new proposal. Even if WCCTAC member agencies in West County received grants and were able to deliver program work, it may not be efficient for them to carry out these activities independently, especially for similar or overlapping efforts.

The TAC is also worried about potential administrative complexity. At present, the CCTA makes TFCA funding available to four subregions. However, if it makes grants available to a larger number of organizations, they will all need to

coordinate with CCTA and work with the Air District's quantitative costeffectiveness reporting requirements, which involve considerable effort. At least one TAC member wondered if the new framework could end up being more administratively intensive and what sort funding the CCTA was using to staff and support this change.

Program Continuity

Lastly, the TAC expressed concern about a potential lack of program or service continuity if annual grants are used to allocate TFCA funds. Transit agencies, for example, noted that very small, one-time grants for service were not especially useful for them. Transit services rely on reasonably predictable and ongoing revenue streams for operations.

• Limited Explanation for Proposed Change – The reasoning behind the proposed change was not clear to the TAC, particularly given that the CCTA has praised the effectiveness of the current program.

The TAC recognizes that the existing program must evolve and adapt to changes in the transportation landscape. It is the TAC's understanding, however, that the program does routinely change. Additionally, if the CCTA, or anyone else, has a new idea for a program offering within a given subregion (or countywide) it is not clear why that could not be accommodated in the existing program.

The CCTA's staff's presentation expressed a desire to not be "out of sync" with the Air District. The meaning of this was not clear but the current program meets Air District's requirements annually and would not be funded if it didn't. The rationale for the change provided by CCTA staff often returned to the theme that the CCTA was not legally obligated to provide funds to subregions or to use them for TDM.

- Geographic Equity In the current TDM program, TFCA funds are provided to subregions using a population and jobs formula. This formula ensures geographic equity. In the proposed grant program, there's not currently a guarantee that West County would receive a proportionate share (or any share) of available TFCA funding or benefits. The WCCTAC TAC and Board are not proposed to be involved in the selection of activities to fund under the new framework. In short, the subregion will have little policy influence over the kinds of projects funded by the grant program.
- **Consideration of Alternatives and Collaboration** The CCTA staff is proposing to significantly alter the TDM program by establishing a new policy for the

allocation of the Air District's TFCA funds. Although the proposed change goes by the name "TDM 2.0" it appears that it will significantly diminish funding to the TDM Program to create a grant program that may or may not be used for TDM. At least one TAC member wondered whether the CCTA could identify other sources of funding to replace the TFCA dollars that would be lost to the current TDM Program.

Other TAC members suggested that the CCTA staff proposal should examine the impacts of the proposed change and offer alternatives. One alternative, for example, could be to allow subregional boards the ability to make choices about the nature of TFCA-funded efforts in their subregion. There could be other alternatives as well.

Lastly TAC members requested that CCTA engage subregional TACs, policy boards, and other local jurisdictions in the development of options. The TAC believes that the CCTA is most successful when there is collaboration with subregions, transit agencies, local jurisdictions, and other partners.
