#### REVIEW AND APPROVE TRI DELTA TRANSIT REQUEST FOR MEASURE J PROGRAM 28d – (EAST COUNTY) SUBREGIONAL TRANSPORTATION NEEDS FUND. TRI DELTA TRANSIT IS REQUESTING FUNDING TO FILL A SHORTFALL IN ITS BUDGET FOR FISCAL YEAR 2024/2025

Robert Sarmiento, TRANSPLAN Committee staff, explained that the Measure J Expenditure Plan had a line-item provision for Program 28 for Subregional Transportation Needs, with East County's share identified as Program 28d that would be allocated to eligible East County transportation projects and programs at the approval of the TRANSPLAN Committee. He explained that there was \$1 million in reserve in Program 28d.

Mr. Sarmiento reported that Tri Delta Transit had submitted a request for \$800,000 of Program 28d funds to fill a shortfall in its 2024/2025 budget. The Contra Costa Transportation Authority (CCTA) managed and disbursed Measure J funding and CCTA's Administration and Projects Committee had approved Tri Delta Transit's authorization request to execute a cooperative agreement between CCTA and Tri Delta Transit to appropriate \$800,000 of 28d funds contingent upon the TRANSPLAN Committee's action.

Rashidi Barnes, Chief Executive Officer (CEO) of Tri Delta Transit, explained that most transit authorities in the area had seen a number of issues with respect to low ridership coupled with issues related to the COVID pandemic along with increases in receivables, fuel, costs of contract and the like, which had created a budget deficit for 2024/2025.

Mr. Barnes explained that Tri Delta Transit was in the middle of a service analysis to analyze every single route and make sure that the agency was efficiently meeting the needs of East County riders, and also making cuts to ensure a balanced budget. The budget shortfall was identified at \$1.6 million. To address that shortfall, Tri Delta Transit had requested the \$800,000 from Program 28d funds, Tri Delta Transit staff would not be taking Cost of Living Adjustments (COLA) and there would be other reductions. He noted that other public transportation services in the Bay Area were having similar problems, and although Tri Delta Transit had a small budget, it was still being impacted.

Mr. Barnes presented Tri Delta Transit's 2024/2025 budget and responded to questions from the TRANSPLAN Committee.

Andy Dillard, Senior Engineer with the CCTA explained that from the perspective of the CCTA, the request from Tri Delta Transit was in line with the Measure J Expenditure Plan.

Members of the TRANSPLAN Committee expressed concern with the request and how to meet obligations in terms of operating budgets, the difficulty for agencies to close another agency's operating budget, whether the \$200,000 remaining in Program 28d if the \$800,000 was approved would be sufficient for reserves, and whether the reserve would keep growing and how, if at all, it would be replenished. It was clarified in the discussion that the CCTA had a reserve policy and did not take from one reserve pile to accommodate another.

Diane Burgis commented that two electric buses were needed for each regular bus because of charging, and when there was hydrogen fuel involved there would be a new cost. She referred to the problems at Tri Delta Transit three years ago of being able to get enough drivers and being able to pay at a level to retain drivers. She explained that Tri Delta Transit was trying to catch up to address those issues that had previously occurred. She recognized that the situation would get worse for the whole transportation infrastructure, explained that CCTA was internationally recognized for the work it did and that Tri Delta Transit was recognized nationally for its work. She added that the Tri Delta Transit Board of Directors had looked at every number to be able to work now and well into the future and the investment requested would help do that. She stated Tri Delta Transit was a leader on the national level providing transportation for the elderly and the disabled to provide direct service. She supported Tri Delta Transit's request enthusiastically.

On motion by Diane Burgis, seconded by Aaron Meadows, TRANSPLAN Committee members approved the request from Tri Delta Transit for \$800,000 in Measure J Program 28d, Subregional Transportation Needs funds, carried by the following voice vote:

# REVIEW TRANSPLAN'S PROPOSED FISCAL YEAR 2024/2025 BUDGET AND WORK PROGRAM, REVISE AS NECESSARY, ADOPT THE BUDGET, AND DIRECT STAFF TO INVOICE MEMBER AGENCIES. THE PROPOSED BUDGET AND WORKPLAN DOES NOT ANTICIPATE ANY SIGNIFICANT DEVIATIONS FROM PRIOR YEARS

Mr. Sarmiento reported that the TRANSPLAN Committee Budget remained about the same from the prior year for a total budget of \$38,864.72. There was currently a \$22,789.84 surplus from the current year that would be applied to the 2024/2025 Budget, and after that a FY 2024/2025 Budget of \$16,074.88.

For the work program, Mr. Sarmiento reported that the Draft Work Program was on pace with Tasks 1-9 being long-standing items, Tasks 10 and 11 carryover projects and programs from last year and Task 12, Transportation Demand Management (TDM) 2.0 was an update of TDM strategies and new strategies to reduce greenhouse gases and reduce Vehicle Miles Traveled (VMT), as well as to address changes to the allocation of Transportation Fund for Clean Air (TFCA) programs.

Mr. Sarmiento recommended that the TRANSPLAN Committee adopt the proposed Fiscal Year 2024/2025 Budget and Work Program and direct staff to send out invoices to each of the five member agencies in the amount of \$3,214.98 each.

On motion by Aaron Meadows, seconded by Juan Banales, TRANSPLAN Committee members adopted the Fiscal Year 2024/2025 TRANSPLAN Work Program and Budget, and directed staff to deliver member dues invoices to the member agencies, carried by the following voice vote:

# RECEIVE REPORT ON CCTA ACTIVITIES FROM TRANSPLAN COMMITTEE REPRESENTATIVES

Aaron Meadows highlighted the discussions of the last CCTA Board meeting, which included an update of the Richmond-San Rafael Bridge Project, the approval of the \$210 million CCTA Budget for 2024/2025, a new lease on the CCTA Building, and the Measure J Audit of the City of Richmond's Paratransit Financials and Service Delivery when the Board had questioned the existence of the program. There had also been discussions related to the Innovate 680 project, and a presentation on the Richmond Ferry Service, its budget and level of service.

Chair Thorpe added that the Board had done a lot of work on appropriations, one of which related to Shared Mobility Hubs and he noted for Antioch, the mobility hub would be critical. He also identified an appropriation for the GoMentum station, and commented that there had been a number of contracts on the agenda given the large projects involved such as the \$500 million Innovate 680 project and the I-680/Highway 4 Interchange and direct connectors project.

Diane Burgis explained that some of the effort on the regional level was to help certain regions in the Bay Area that were really hurting transportation wise, and the more stabilization that could be offered the better.

#### RECEIVE MISCELLANEOUS TRANSPLAN COMMITTEE MEMBER COMMENTS

Bob Mankin highlighted the activities of the County Planning Commission and the fact that the first draft of the General Plan amendments countywide would be coming up for discussion shortly.

Diane Burgis referred to a recent meeting with Sons in Retirement (SIR) Branch 161 in Discovery Bay and the frustration that group had expressed that State Highway 239 would not be going through.

Mr. Sarmiento stated he had reached out to CCTA staff who would come to the next meeting to discuss SR 239. As to the next meeting scheduled for July 11, he had been informed that meeting could be bumped by the Mayors' Conference, which had to be moved to that date from July 4. He explained that there would be one or two items for the July meeting.

After a brief discussion, the TRANSPLAN Committee determined to cancel the July meeting and to hold the meeting scheduled for August 8, 2024.

#### <u>ADJOURNMENT</u>

Chair Thorpe adjourned the meeting of the TRANSPLAN Committee at 7:17 P.M. to the next meeting on Thursday, August 8, 2024 at 6:30 P.M. or other date/time as deemed appropriate by the Committee.

**Project Description:** Construct a pedestrian and bicycle overcrossing near the Mokelumne Trail at SR4. The overcrossing will include a multi-span bridge with columns in the SR4 median. Bridge approaches will be constructed on earthen embankments. The path width is assumed to be 12 feet wide. This project is required as a condition of approval under the SR-4 Bypass project.

**Current Phase:** Post Construction.

#### **Project Status:**

- A Joint Exercise Powers Agreement (JEPA) between SR4 Bypass Authority (SR4BA), ECCRFFA, City of Brentwood and CCTA to define and establish the roles and responsibilities for the project was approved by the Authority Board in July 2020.
- The Authority awarded the construction contract to Joseph J. Albanese in September 2021.
- Groundbreaking ceremony was held on March 18, 2022.
- Ribbon cutting was held in March 2024.

#### **Issues/Areas of Concern:**

Germination of the permanent erosion control features has not been sufficient to close the environmental permits. Additional erosion control work will need to be performed, extending the contract completion date.

#### **Update from Previous Quarterly Report**

- Project is in the Permanent Erosion Control Establishment phase.
- <u>Closeout of applicable portions of the project has commenced.</u> Project will be moved to the completed list in the next update.

## **STATE ROUTE 239 (#5007)**

#### Scope:

State Route 239 (SR239) was first legislated in 1959 as a possible roadway linking SR4 in Brentwood to I-205 or I-580 west of Tracy. A Feasibility Study and a Project Initiation Document were completed in 2015. The current scope is to complete the preliminary engineering and environmental document (PAED) for SR239 to determine its alignment, complete the State Route Adoption process, and to identify and obtain environmentally approval for an initial segment to proceed with design and construction.

**Administration**: Responsibility for the State Route 239 Study the associated federal funding was transferred from Contra Costa County to the Contra Costa Transportation Authority in January 2012.

**Current Phase:** Environmental Clearance

#### Status

- Feasibility study and project initiation document have been completed.
- The PAED work is ongoing.

#### **Issues/Areas of Concern**

- Significant funding is needed to complete project and a two-tiered process is being contemplated to be consistent with project phasing.
- The proposed hybrid programmatic and project level PAED is new to Caltrans District 4. Staff is working with Caltrans to develop and address new mandates and policies on Vehicle Miles Traveled and Climate Change. The includes transit and other transportation modes.
- COVID-19 has significantly impacted traffic movement and the project team is developing an alternative approach to conduct traffic study for the project.
- Coordination with other projects in the project area will minimize potential major conflicts.
- Project has to adapt to changing environmental protocols.

#### **Update from Previous Quarterly Report**

- Consultant has completed most of the field reviews and surveys and is focusing on preparing various environmental technical studies. Caltrans is coordinating with resource agencies to discuss specific issues.
- Project alternatives are continually being updated, refined, and evaluated based on coordination with other projects, public input and to minimize environmental impacts, utilizing information from the latest field surveys.
- <u>A draft bike plan is continually being updated with other planned public access and trail</u> <u>improvements. Project includes multi-modal project elements which may include accommodation for future micro-transit.</u>
- The project team had submitted a plan to meet Senate Bill 743 (SB 743) vehicle miles traveled (VMT) requirements for Caltrans review.

• The project funding deadline was extended to June 30, 2026 to reflect the complex nature of the project.

# COMPLETED PROJECTS STATE ROUTE 4 WIDENING

D. SR4 Widening: Railroad Avenue to Loveridge Road COMPLETED

Lead Agency: CCTA

**Project Description**: The project widened the existing highway from two to four lanes in each direction (including HOV lanes) from approximately one mile west of Railroad Avenue to approximately ¾ mile west of Loveridge Road and provided a median for future transit.

Current Project Phase: Completed.

**Project Status**: Landscaping of the freeway mainline started in December 2009 and was completed in June 2010. A three-year plant establishment and maintenance period is currently in progress as required by the Cooperative Agreement with Caltrans, was completed on June 24, 2013. Caltrans has accepted the project and will take over the maintenance responsibilities. The CCTA Board accepted the completed construction contract, approved the final contractor progress payment, approved the release of the retention funds to the contractor, and authorized staff to close construction Contract No. 241 at its September 18, 2013 meeting.

Issues/Areas of Concern: None.

E. SR4 Widening: Loveridge Road to Somersville Road COMPLETED

**Lead Agency**: CCTA

**Project Description**: The project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) between Loveridge Road and Somersville Road. The project provides a median for future mass transit. The environmental document also addresses future widening to SR 160.

Current Project Phase: Completed.

**Project Status**: Caltrans accepted the contract on June 30, 2014. The construction contract is now closed with no outstanding claims.

Issues/Areas of Concern: None.

F. SR4 Widening: Somersville Road to SR 160 COMPLETED

Lead Agency: CCTA

**Project Description**: This project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) from Somersville Road to Hillcrest Avenue (plus auxiliary lanes), including a wide median for transit, and then six lanes to SR160 and the new SR4 Bypass.

The project was constructed in five segments:

- Segment 1: Somersville Road to Contra Loma Boulevard.
- Segment 2: Contra Loma Boulevard to A Street/Lone Tree Way.
- Segment 3A: A Street/Lone Tree Way to Hillcrest Avenue.
- Segment 3B: Hillcrest Avenue to SR160.
- Corridor-wide: Landscaping.

Current Project Phase: Completed.

**Project Status**: The project is divided into four segments: 1) Somersville Interchange; 2) Contra Loma Interchange and G Street Overcrossing; 3A) A Street Interchange and Cavallo Undercrossing and 3B) Hillcrest Avenue to Route 160.

**Segment 1:** Somersville Interchange

Segment was open to traffic in December 2013.

**Segment 2:** Contra Loma Interchange & G St. Overcrossing

Construction began in March 2012 and was completed in February 2016. Project History Files have been submitted to Caltrans.

**Segment 3A:** A Street Interchange and Cavallo Undercrossing

Construction began in August 2012 and was accepted as complete in May 2017.

**Segment 3B:** Hillcrest Avenue to SR160

Construction and BART bike safety improvements have been completed.

#### Recommendation

APPROVE TRANSPLAN TAC recommendation to appoint Anju Pillai (Brentwood) to the Contra Costa Transportation Authority (CCTA) Technical Coordinating Committee (TCC).

#### **Background**

The TCC provides input on technical matters that come before CCTA. The TCC also acts as the primary technical liaison between CCTA and the Regional Transportation Planning Committees. The TCC consists of 24 technical staff members appointed by:

- Each of the four Regional Transportation Planning Committees (RTPCs),
- Contra Costa County,
- One from each of the transit service providers (BART, AC Transit, Tri Delta and WestCAT),
- The City-County Engineering Advisory Committee, and
- One ex-officio member each from Caltrans, Metropolitan Transportation Commission and the Bay Area Air Quality Management District.

Each RTPC is permitted to appoint three members to the TCC. A TCC representative term lasts for two years and can be renewed.

At its December 2023 meeting, the TRANSPLAN Committee approved the re-appointments of Steve Kersevan (Brentwood) and Kevin Rohani (Oakley) and the appointment of Ethan Angold (Antioch) to the TCC. At its February 2024 meeting, the TRANSPLAN Committee approved the appointment of Khristin Labao (Pittsburg) to the TRANSPLAN TCC representative position that was vacated by Mr. Angold. In August 2024, TRANSPLAN staff was informed that Mr. Kersevan was no longer employed by the City of Brentwood; thus, his TRANSPLAN TCC representative position became vacant. The TRANSPLAN TAC recommends the appointment of Anju Pillai (Brentwood) to the vacant TRANSPLAN TCC representative position.

Once approved, TRANSPLAN staff will notify CCTA of the TRANSPLAN representative appointment to the TCC.








CONNECTION BETWEEN SR4 IN BRENTWOOD TO I580 WEST OF TRACY





#### Recommendation

**REVIEW** countywide proposals for Transportation for Clean Air (TFCA) program funds and **PROVIDE** input, and **REVIEW** and **APPROVE** Tri Delta Transit proposal for East County TFCA program subregional funds.

#### **Background**

#### New TFCA Policy

In past years, The TFCA program was combined with the Measure J – Program 17 to fund TDM activities that 511 Contra Costa (511CC) carries out in East County on behalf of TRANSPLAN jurisdictions. In January 2024, Contra Costa Transportation Authority (CCTA) staff initiated a process to change the allocation policy of TFCA funds. After several rounds of discussion, a new TFCA policy (attached) was adopted by the CCTA Board on May 15, 2024.

Under the new TFCA policy, TFCA funds will be available for eligible vehicle miles traveled (VMT)-and greenhouse gas (GHG)-reducing activities. These typically include bicycle/pedestrian projects, ridesharing services, first/last-mile connections, vehicle- and fuel-based projects, and telecommuting, all of which must meet cost-effectiveness ratios. Cities, the County, CCTA, public transit agencies, and the RTPCs are eligible to apply for TFCA funds. TFCA funding will be available to both:

- countywide projects and programs that benefit all County residents and commuters, and
- subregional projects and programs, which benefit one or more subregions but not the entire county.

Funding for Countywide programs will be "taken off the top" of the total TFCA funding. Countywide projects and programs are reviewed by CCTA staff and RTPC managers and approved by the CCTA Board. Remaining TFCA funds will be divided among the RTPCs based on the number of jobs and housing units in each RTPC and allocated to subregional projects and programs. The RTPCs will review subregional projects and programs and approve recommendations to the CCTA Board.

According to CCTA staff, school-based TDM programs will continue to be funded in East County<sup>1</sup>. Other existing TDM programs in East County may either be funded through the countywide programs in the TFCA program (See below.), funded by available Measure J – Program 17 funds, or **eliminated.** 

<sup>&</sup>lt;sup>1</sup> These programs will be funded by carryover TFCA and Measure J – Program 17 funds in FY 2024/25 and One Bay Area Grant 3 (OBAG3) from FY 2025/26 through FY 2028/29.

#### TFCA Call for Projects

On May 16, 2024, CCTA released a countywide call for projects for the FY 2024/25 cycle of TFCA fund allocations, and subsequently, the application period ended on June 5, 2024. CCTA received the following **countywide** proposals, which will provide TDM benefits to East County residents:

- Countywide Brand and Web Portal: TFCA funds will be used to maintain the 511CC brand and the 511CC website.
- **Vanpool**: Sponsored by SWAT, this program will provide assistance and coordination of vanpool ride-matching workshops for worksites to encourage vanpooling instead of driving alone. In addition, this program will provide countywide vanpool passenger and driver incentive programs.
- **Guaranteed Ride Home**: WCCTC will provide the Contra Costa Guaranteed Ride Home program countywide. The program reimburses for emergency Uber, Lyft, and taxi rides home if the participant took transit, carpooled, vanpooled, biked, or walked on the day of the emergency. The program allows for up to six reimbursements per year (the first 2 at 100% reimbursement, the following 4 at 75%).
- Spare the Air Big Win on Transit + Seasonal Programs: For the year-round "Win Big on Transit" program, CCTA will use TFCA funding to provide cash incentives for people who use Clipper cards on transit trips (bus, BART, ferry) that start or end in Contra Costa County, instead of driving alone. The program will provide one \$511 reward per week to a randomly selected eligible participant. Various additional incentives will be offered on official Spare the Air days. In addition, the Countywide Spare the Air Incentives Program will provide supporting promotions that encourage the other (non-transit) alternative modes, including active transportation and carpooling.
- Pass2Class Student Bus Pass Program: CCTA will use funds to provide up to two months of free rides on public transit (County Connection, Tri Delta Transit, WestCAT, and AC Transit) for up to two students per household at the beginning of the school year to help students/families build a transit habit for the school commute.

CCTA received one East County **subregional** proposal:

**Tri Delta Transit Tri MyRide Service Expansion**: Tri Delta Transit will use TFCA funding to increase service levels for the Oakley/Antioch zone of Tri MyRide service. The service expansion will increase the number of all-day vehicles in service from three to five. Tri Delta Transit's proposal requests the entire TFCA subregional allocation for East County. (Summary attached.)

At its June 18, 2024 meeting, the TRANSPLAN TAC received a presentation from CCTA staff on the TFCA Call for Projects, provided input on the countywide programs, and recommended moving the Tri Delta Transit subregional proposal to the TRANSPLAN Committee for approval.



# TFCA 40% Fund Policy and Process

- Authority Board approved the TFCA 40% Fund Policy on May 15, 2024.
- Upon approval of the Policy, a Call for Projects was released, opening the allocation of TFCA 40% funds to eligible sponsors.
- Project sponsors had three weeks to respond to the Call.
- Funds available for FY 24/25 projects after the deduction of administrative costs is \$1,747,938.

# Project Evaluation Process

Ten project proposals: four countywide and six subregional. Total requested funds: exceeded the available fund by \$487,591.

### CCTA Staff Review

All projects were determined to be:

- Submitted by eligible sponsors
- Consistent with state law in category and vehicle emission reduction
- Consistent with Air District polices
- Cost Effectiveness (CE) ratio below the maximum threshold for the project type.
