The TRANSPLAN Committee changed the order of the agenda to consider approving FY 2025/26 Transportation for Clean Air (TFCA) East County subregional program allocations prior to considering an update to the Draft Integrated Transit Plan (ITP).

APPROVE FISCAL YEAR 2025-26 TRANSPORTATION FUND FOR CLEAN AIR (TFCA) EAST COUNTY SUBREGIONAL PROGRAM ALLOCATIONS

Two proposals request TFCA East County subregional program allocation, totaling \$215,133.88.

Robert Sarmiento, TRANSPLAN staff, identified the proposed East County Subregional Program Allocations for the FY 2025-26 Transportation Fund for Clean Air (TFCA) funds, and stated the proposed allocations were for two programs: the Tri MyRide Service Expansion and the Walk & Roll program within the TRANSPLAN Committee region. He explained that beginning last year, TFCA funds received from the Bay Area Air Quality Management District (Air District) changed the distribution of TFCA funding from a formula-based method to a competitive application process. Under the new distribution process, funding was allocated first to county programs, while the remaining TFCA funds would be distributed to each subregion based on a jobs/housing formula.

For the current 2025-26 cycle, the Contra Costa Transportation Authority (CCTA), which administers TFCA funds in Contra Costa County, had received \$1,891,105 in TFCA funds, and of that amount \$1,063,115 would be allocated to the countywide programs. Of the remaining \$827,990, 26 percent would go to East County to fund two East County programs; the Tri MyRide Service Expansion and the Walk & Roll program. The CCTA Board of Directors had approved the funding for both programs, as recommended, at its October 15, 2025 meeting and TFCA funding for East County would move forward with that approval.

KIRSTEN RIKER, 511 Contra Costa, responded to comments with respect to the Walk & Roll program that was a fairly new program that had started in one school in Pleasant Hill in the TRANSPAC region three or four years ago, and had caught on like wildfire. The program, activated one day each week, encouraged elementary school students to bike, walk, carpool, use transit, or park and walk for those who could not get to school in an active way, through the use of a backpack and incentive prizes and engagement activities.

Ms. Riker reported that the Walk & Roll program had been very effective and schools had reported fewer tardies on program days, and on non-program days, bike counts had increased and students were starting to get into the biking habit.

Ms. Riker added that up to 15 schools in the TRANSPAC region were utilizing the program with more joining every day, and schools in the other regions were now interested in the program, and CCTA was interested in making it a countywide program. Staff was attempting to get more TFCA funding to expand the program to more schools. The TFCA funding would allow three more East County schools to start the program this year, with more going forward.

With respect to the Tri MyRide program, an on-demand, corner-to-corner shared shuttle service provided by Tri Delta Transit, service areas included Pittsburg-Bay Point, Antioch-Oakley, and Brentwood. Last year was the first year that Tri Delta Transit had received TFCA funding for the Tri MyRide program.

An unidentified speaker compared the benefits of the Walk & Roll program with the Tri MyRide service expansion, and expressed a preference for a program to help people get to transit as opposed to "putting charms on a backpack" incentive approach to encourage kids to bike, walk and carpool to school.

RASHIDI BARNES, Chief Executive Officer (CEO), Tri Delta Transit, spoke in support of the Tri MyRide program which moved about 10,000 people a month and there was a desire to support the expansion of the program to be able to continue serving the public. He agreed that trying to sensitize youth to use the system would be beneficial but utilizing transit should be a piece of that offering.

Diane Burgis asked whether 511 Contra Costa staff had reached out to the schools to secure funding for the Walk & Roll program. She asked if the school districts were eligible to receive TFCA funds, and she referred to Liberty High School in Brentwood that had a bus and Oakley and Byron/Knightsen, and asked if those districts would quality for TFCA funding.

DANIELLE ELKINS, Deputy Executive Director of Planning, Programs, and Policy, CCTA, advised if those entities could meet the requirements of the TFCA funding, they would be eligible. She noted the TFCA funding was over-subscribed and CCTA had asked that Walk & Roll cut back the TFCA fund request to add only three East County schools to the program, with the remainder of the TFCA funds for East County to be used for the Tri MyRide program. She commented that recommendation was supposed to have been approved by the TRANSPLAN Committee last week, although that meeting had been cancelled due to a conflict with the League of California Cities Annual Conference and Expo.

Ms. Riker stated that part of the beauty of the Walk & Roll program was that the trips were scanned in real time, and part of the scanning recorded a default mode so that students did not have to provide personal information. The default distance was one mile, but the actual miles could be noted and tracked for Vehicle Miles Traveled (VMT) reductions. She added that because of the age category, most kids were driven to school and were less likely to use transit.

Sarah Foster referred to the Walk & Roll program and other factors involved, such as the buy-in from parents, the location of the school with respect to the safety of the environment, and stated that marketing materials should be in English and Spanish. The schools involved would also need bike parking.

Ms. Riker stated that bike racks were filling up at the schools and bicycle racks were able to be provided as part of the Walk & Roll program. She added that Fall outreach at all of the schools provided safety education and with that safety aspect she would be providing information about the Walk & Roll program on a first-come first-served link so that people could ask questions and learn about the program. She added that everyone was welcome to come to the Walk & Roll events and she invited members of the TRANSPLAN Committee to do that. She also noted that some schools had perfect conditions for biking and walking while others might be trickier. Through the 511 Contra Costa program, matching funding might be possible from other sources.

When asked about the VMT data, Ms. Riker referred to the quarterly reporting and stated that with seven schools participating in last year's pilot year, 2,749 students had participated and the total VMT reduction recorded for that was 1,263,849 miles. The Walk & Roll program was a cost-effective program per Air District regulations at \$141,361 per ton.

Juan Banales reported on the use of the Tri MyRide program in his community and stated it had been an effective program that he wanted to continue. He recognized the Walk & Roll program was a new program but he did not see taking away from Tri MyRide, which had been so helpful to his community, was looking to expand, and which had first mile/last mile significance.

Aaron Meadows left the meeting at this time but returned later.

Chair Susannah Meyer was present to chair the meeting.

There was a proposal to allocate the full amount to the Tri MyRide program with no allocation to the Walk & Roll program.

When asked if the Tri MyRide program would be reduced without receipt of the total allocation of TFCA funding, Mr. Barnes explained that if the program was funded the \$153,853.88, as initially proposed, the Tri MyRide service would be impacted this year in the fall. He noted it had become a lifeline for some of the student trips and he was asked to identify the percentage of riders who were students.

On motion by Juan Banales, and second by Diane Burgis, TRANSPLAN Committee members APPROVED the full FY 2025/26 TFCA East County subregional allocation of \$215,133.88 to the Tri MyRide Service Expansion, with allocations to school districts to be eligible for the outreach so that different ways of getting kids to school could be considered. The motion carried by the following vote:

Given that CCTA had already acted to approve the original recommendation on October 15, 2025 to fund both Tri MyRide and Walk & Roll programs, it was noted that the TRANSPLAN Committee's modification to that funding allocation would result in the TFCA funding allocations returning to the CCTA Board of Directors for new action.

RECEIVE UPDATE ON THE DRAFT INTEGRATED TRANSIT PLAN

CCTA staff and consultants will present an update on the Integrated Transit Plan (ITP), sharing project evaluation results, and capital and operations cost estimates for proposed ITP projects, as well as how feedback provided by the TRANSPLAN Committee to the Spring update has been addressed.

DANIELLE ELKINS, Deputy Executive Director of Planning, Programs, and Policy, CCTA, represented CCTA. Kevin Connolly, TYLin and Monica Tanner, Kimley-Horn represented the consultants involved in the Draft ITP.

KEVIN CONNOLLY, TYLin, referred to the last presentation to the TRANSPLAN Committee in the Spring and the consultants' evaluation of the recommendations received as well as the cost of a Draft ITP. He referred to a number of good insights, stated the consultants had read, answered, and acknowledged where bike lanes had already been planned and were assumed to be included in the ITP for costing purposes. He added that the design phase in the future would address bikes in more detail.

Mr. Connolly identified the entire network of all existing transit in Contra Costa County and noted the focus of the effort was on bus service, not so much on commuter service and regional rail. There had been little attention to frequent bus service, with a 15-to-20-minute frequency in a 19-hour service span, and where today, only a small percentage met that service level. He also commented that there were not so many Transit Priority Corridors (TPC) in East County, although there were many in West County and Central County.

MONICA TANNER, Kimley-Horn, spoke to the evaluation process to evaluate TPCs, Mobility Hubs and Access Improvement Zones (AIZs), along with the evaluation criteria.

Diane Burgis requested that acronyms be described.

Ms. Tanner identified the evaluation criteria used to make improvements, how people would be connected with high-speed transit and more jobs, alignment with regional priorities and addressing a regional transit gap, how that would benefit equity priority communities, the ridership potential, travel time benefits, and development opportunities to promote economic development, along with what could occur if there were no transit improvements on the corridors and the congestion that was expected to occur by 2050.

Ms. Tanner identified the objectives and performance measures for accessibility to high-frequency transit and connectivity to the transit network, and showed the concentration of people who would have access to transit through the corridors. With the improvements, people would have more access to transit. She pointed out graphs of the transit investment evaluation summary for ITP results, scoring and mobility hub results along with a mobility hubs evaluation summary results map, and a transit investment evaluation summary and results map.

Ms. Tanner spoke to the capital and operations cost estimates for TPC and highlighted proposed bus stop improvements, intersection improvements, a bus-only lane where noted as a candidate for transit lanes, new zero-emission buses, and estimated costs. All costs were for current year dollars. Mobility hub capital cost estimates and assumptions also identified bus stop improvements, intersection improvements on the intersections and streets directly adjacent to the hubs, support services and amenities. Those estimates did not assume right-of-way costs since most locations were already publicly-owned. Access improvement zone capital cost estimates and assumptions were for pedestrian and wayfinding improvements and bicycle improvements. The total capital improvements and costs were for nine Transit Priority Corridors, 36 mobility hubs, 250 miles of pedestrian and wayfinding improvements, and 200 miles of bicycle improvements.

Mr. Connolly identified the general cost modeling approach, estimated operating expenses for all transit operators, and explained that the actual cost represented an 80 percent increase over today's annual operating expense and varied by the expense and other services in the area. For Tri Delta Transit, for instance, there would be a 31 percent increase in cost. He referred to the study as aspirational and explained that all costs and information would be detailed and shared with the various operators to use as a starting point for future project development.

For next steps, Mr. Connolly reported that the information would be presented to all the Regional Transportation Planning Committees (RTPCs), and then the ITP report would be submitted to the CCTA Board for adoption sometime in the first quarter of the new year. A Draft Final Report would be produced prior to the adoption of the document.

Diane Burgis referred to the estimated 31 percent increase in operational costs for Tri Delta Transit and expressed concern since Tri Delta Transit expected a bigger reduction in revenue. She asked about the highest priority for the ITPs.

Mr. Connolly stated the proposal was an examination of the vision of what could be. He noted that frequent bus improvements could happen quickly but the longer-term endeavors would obviously take longer.

Ron Bernal referred to Page 81 of the agenda packet and the details related to TPC 6 that had the most economic development potential. He asked why there was a gap for not completing that connection to Walnut Creek. He then referred to Page 38, the locations of TPCs and candidate TPC improvements and asked why that was not connected.

Mr. Connolly clarified that there would be improvements but no dedicated lanes on Kirker Pass Road given that the area was treacherous and based on that fact he did not think the investment would be comparable.

Mr. Bernal noted that development was very important, but an accident on Highway 4 could create serious congestion and it would be an important project to include in the analysis.

Juan Banales suggested that if pursuing Railroad Avenue in Pittsburg as a dedicated lane for buses would have significant impacts on existing traffic. He agreed that dedicated lanes needed to be added over Kirker Pass Road. He wanted to talk about real impacts and meaningful improvements to traffic times. In the absence of data, he had a hard time believing what was there in terms of actual impact and suggested there would be significant consequences to implement the improvements proposed in the ITPs if there were no dedicated lanes added in both directions. He also saw problems with right-of-way access on Railroad Avenue in terms of cost.

Diane Burgis anticipated a lot of impact on traffic related to the Concord Naval Weapons Station development and suggested that road would be more important in the future, and there would be less investment to do that now as opposed to in the future.

Other comments were that the impacts would be far reaching.

Rashidi Barnes agreed the proposed ITP was a huge project. He was encouraged that the TRANSPLAN Committee had taken the time to review the project and he was appreciative of the input. He noted that Tri Delta Transit had been working with CCTA on the development of the ITPs.

Ron Bernal emphasized that the process should not only be thinking of people leaving East County but also be cognitive of people on transit coming into East County.

APPROVE 511 CONTRA COSTA REQUEST TO ALLOCATE MEASURE J PROGRAM 17 FUNDS (COMMUTE ALTERNATIVES) TOWARDS THE INSTALLATION OF E-LOCKERS IN THE CITY OF ANTIOCH

Kirsten Riker spoke to the Bicycle Parking Infrastructure Program that generally related to a bike rack or sometimes to repair stations, and through the use of Measure J Program 17 Funds (Commute Alternatives) she had offered the opportunity for a limited number of bicycle e-lockers to TRANSPLAN member agencies. She noted the City of Antioch was the only member agency that had responded to that offer. She advised that \$53,000 had been allocated to the project and eLock Technologies, the e-locker company, had negotiated with the City of Antioch on terms for the service and a licensing agreement was ready to proceed with the installation of eight high-security bike e-lockers.

In response to questions, Ms. Riker stated that two of the e-lockers would be installed at Antioch City Hall to accommodate four bicycles, and there would be another two lockers at the Community Center for four bicycles. She clarified that 511 Contra Costa was funding a five-year service and maintenance agreement provided by eLock Technologies. After that period, the City of Antioch would be responsible for maintaining the fairly low-cost service agreement.

On motion by Ron Bernal, and second by Juan Banales, TRANSPLAN Committee members APPROVED 511 Contra Costa's request to allocate Measure J Program 17 funds towards the installation of e-lockers in the City of Antioch. The motion carried by the following vote:

Current Phase: Environmental Clearance

Project Status:

- The Initial Phase of the project is in the Project Approval/Environmental Document (PA/ED) Phase.

Issues/Areas of Concern: The Overall Project has significant funding shortfall.

Update from Previous Quarterly Report

- Project work is currently on hold until next steps to address SB 743 are determined.
- In anticipation of restarting work on Phase 1, term extension to the agreement with the consultant team was approved by the Authority Board in July 2025.
- Schedule has been updated based on the latest information.

B. State Route 4 Integrated Corridor Management (ICM) (#28002)

CCTA Fund Source: Measure J/FHWA/TBD

Lead Agency: Contra Costa Transportation Authority

Project Description: Use state-of-the-practice Intelligent Transportation System (ITS) technologies to enhance the effectiveness of the existing transportation system along State Route 4 (SR4) and parallel/crossing arterials between SR160 and Interstate 80 (I-80). Project elements include the following:

- Operational strategies based on real-time traffic conditions along the corridor (a.k.a. Decision Support System)
- Adaptive ramp metering

- Incident management with speed harmonization
- Traffic and transit Information System
- Arterial and transit improvements
- Connected Vehicle (CV) applications/technologies
- Integration with the I-80 Integrated Corridor Management (ICM).

The SR 4 ICM may be combined with one or more packages of the SR 4 Operational Improvements (Project 6006).

Current Phase: Environmental Clearance

Project Status:

- Project was awarded a Federal Highway Administration (FHWA) ICM Planning Grant.
- Completed Systems Engineering Management Plan (SEMP) 2 System Requirements Concept of Operations (ConOps) report.

Issues/Areas of Concern: Must compete for additional grants:

- a) \$6 million for Phase 2 implementation
- b) \$4.75 million CV Pilot Deployment

Update from Previous Quarterly Report

Project is on hold pending future funding.

STATE ROUTE 239 (#5007)

Scope:

State Route 239 (SR239) was first legislated in 1959 as a possible roadway linking SR4 in Brentwood to I-205 or I-580 west of Tracy. A Feasibility Study and a Project Initiation Document were completed in 2015. The current scope is to complete the preliminary engineering and environmental document (PAED) for SR239 to determine its alignment, complete the State Route Adoption process, and to identify and obtain environmentally approval for an initial segment to proceed with design and construction.

Administration: Responsibility for the State Route 239 Study the associated federal funding was transferred from Contra Costa County to the Contra Costa Transportation Authority in January 2012.

Current Phase: Environmental Clearance

Status

- Feasibility study and project initiation document have been completed.
- The PAED work is ongoing.
- The project funding deadline was extended to June 30, 2026 to reflect the complex nature of the project.

Issues/Areas of Concern

- Significant funding is needed to complete project and a two-tiered process is being contemplated to be consistent with project phasing.
- The proposed hybrid programmatic and project level PAED is new to Caltrans District 4.

- The Transfer-Bethany Pipeline has been terminated and is no longer a project constraint.
- The project team continues to coordinate with the Delta Conveyance project for mutual compatibility.
- Project has to adapt to changing environmental protocols.

Update from Previous Quarterly Report

- <u>Consultant has completed the majority of environmental technical studies. The team is discussing the streamlining of the Draft Environmental Document preparation and review.</u>
- Project alternatives are continually being updated, refined, and evaluated based on coordination with other projects, public input and to minimize environmental impacts, utilizing information from the latest field surveys.
- Consultant and Caltrans completed the consultation process with various resource agencies, and the guidance and information received has been beneficial in developing and refining the study alternatives.
- Wildlife movement camera survey at multiple locations and movement study are ongoing.
- Project includes multi-modal project elements which may include accommodation for future transit and micro-transit facilities.
- The project team is refining studies, including plan to address Senate Bill 743 (SB 743) vehicle miles traveled (VMT) requirements.
- An alternative evaluation matrix had been presented to project stakeholder agencies.
- Advance agency outreach will precede release of draft environmental document for public review in spring 2026.

STATE ROUTE 4 WIDENING

C. SR4 Widening: Railroad Avenue to Loveridge Road COMPLETED

Lead Agency: CCTA

Project Description: The project widened the existing highway from two to four lanes in each direction (including HOV lanes) from approximately one mile west of Railroad Avenue to approximately ¾ mile west of Loveridge Road and provided a median for future transit.

Current Project Phase: Completed.

Project Status: Landscaping of the freeway mainline started in December 2009 and was completed in June 2010. A three-year plant establishment and maintenance period is currently in progress as required by the Cooperative Agreement with Caltrans, was completed on June 24, 2013. Caltrans has accepted the project and will take over the maintenance responsibilities. The CCTA Board accepted the completed construction contract, approved the final contractor progress payment, approved the release of the retention funds to the contractor, and authorized staff to close construction Contract No. 241 at its September 18, 2013 meeting.

Issues/Areas of Concern: None.

D. SR4 Widening: Loveridge Road to Somersville Road COMPLETED

Lead Agency: CCTA

Project Description: The project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) between Loveridge Road and Somersville Road. The project provides a median for future mass transit. The environmental document also addresses future widening to SR 160.

Current Project Phase: Completed.

Project Status: Caltrans accepted the contract on June 30, 2014. The construction contract is now closed with no outstanding claims.

Issues/Areas of Concern: None.

E. SR4 Widening: Somersville Road to SR 160 COMPLETED

Lead Agency: CCTA

Project Description: This project will widen State Route 4 (e) from two to four lanes in each direction (including HOV Lanes) from Somersville Road to Hillcrest Avenue (plus auxiliary lanes), including a wide median for transit, and then six lanes to SR160 and the new SR4 Bypass.

The project was constructed in five segments:

- Segment 1: Somersville Road to Contra Loma Boulevard.
- Segment 2: Contra Loma Boulevard to A Street/Lone Tree Way.
- Segment 3A: A Street/Lone Tree Way to Hillcrest Avenue.
- Segment 3B: Hillcrest Avenue to SR160.
- Corridor-wide: Landscaping.

Current Project Phase: Completed.

Project Status: The project is divided into four segments: 1) Somersville Interchange; 2) Contra Loma Interchange and G Street Overcrossing; 3A) A Street Interchange and Cavallo Undercrossing and 3B) Hillcrest Avenue to Route 160.

Segment 1: Somersville Interchange

Segment was open to traffic in December 2013.

Segment 2: Contra Loma Interchange & G St. Overcrossing

Construction began in March 2012 and was completed in February 2016. Project History Files have been submitted to Caltrans.

Segment 3A: A Street Interchange and Cavallo Undercrossing

Construction began in August 2012 and was accepted as complete in May 2017.

Segment 3B: Hillcrest Avenue to SR160

Construction and BART bike safety improvements have been completed.

Corridor-wide:

Ribbon cutting ceremony held on July 20, 2016.

Issues/Areas of Concern: None

F. SR4 Bypass: SR4/SR160 Connector Ramps COMPLETED

Project Fund Source: Bridge Toll Funds

Lead Agency: CCTA

Project Description: Complete the two missing movements between SR4 Bypass and State Route 160, specifically the westbound SR4 Bypass to northbound SR160 ramp and the southbound SR160 to eastbound SR4 Bypass ramp.

Current Phase: Completed.

Project Status:

- The project opened to traffic on February 29, 2016.
- Final paving is complete and a ribbon cutting was held on February 29, 2016.

Issues/Areas of Concern: None.

STATE ROUTE 4 (FORMER "BYPASS" PROJECT)

G. SR-4: Widen to 4 Lanes – Laurel Rd to Sand Creek Rd & Sand Creek Rd I/C – Phase 1 COMPLETED

Project Description: Widen the State Route 4 Bypass from 2 to 4 lanes (2 in each direction) from Laurel Road to Sand Creek Road, and construct the Sand Creek Interchange. The interchange will have diamond ramps in all quadrants with the exception of the southwest quadrant.

Project Status: Construction completed 2015.

H. SR-4: Balfour Road Interchange – Phase 1 (5005) COMPLETED

The TRANSPLAN Committee undertook the following activities during its special meeting on October 16, 2025:

- 1. Received an update on the Draft Integrated Transit Plan (ITP) from CCTA staff. The TRANSPLAN Committee commented on the importance of transit enhancements, including a potential dedicated transit lane, along the segment of Kirker Pass Road between Concord and Pittsburg, especially in consideration of future transportation impacts from the Concord Naval Weaspons Station redevelopment and when an accident occurs on State Route 4 and subsequently creates congestion on that highway. In addition, the TRANSPLAN Committee commented that the installation of new dedicated transit lanes along Railroad Avenue, as highlighted in the ITP, should not involve the conversion of existing travel lanes. Finally, the TRANSPLAN Committee stated that the ITP should consider the movement of people traveling to East County, not just travelers leaving East County.
- 2. Approved the FY 2025/26 Transportation for Clean Air (TFCA) East County Subregional Program Allocations. The TRANSPLAN Committee approved the full allocation of the FY 2025/26 East County subregional program funds to the Tri Delta Transit Tri MyRide service expansion. (The staff recommendation was to approve the allocation of a portion of the TFCA East County subregional funds to 511 Contra Costa's new Walk & Roll program for East County and the rest to the Tri MyRide service expansion, consistent with the FY 2025/26 TFCA funding allocations for TFCA proposals countywide that had recently been approved by the CCTA Board.)
- 3. Approved a 511 Contra Costa request to allocate Measure J Program 17 (Commute Alternatives) funds towards the installation of e-lockers in the City of Antioch, along with maintenance of the e-lockers for five years.

Background

The TCC provides input on technical matters that come before CCTA. The TCC also acts as the primary technical liaison between CCTA and the Regional Transportation Planning Committees. The TCC consists of 24 technical staff members appointed by:

- Each of the four Regional Transportation Planning Committees (RTPCs),
- Contra Costa County,
- One from each of the transit service providers (BART, AC Transit, Tri Delta and Westcat),
- The City-County Engineering Advisory Committee, and
- One ex-officio member each from Caltrans, Metropolitan Transportation Commission and the Bay Area Air Quality Management District.

Each RTPC is permitted to appoint three members to the TCC. A TCC representative term lasts for two years and can be renewed.

The TRANSPLAN representatives to the TCC are as follows:

- Kevin Rohani (Oakley)
- Anju Pillai (Brentwood)
- Gina Haynes (Pittsburg)

In October 2025, TRANSPLAN staff was informed that Mr. Rohani would be vacating his TRANSPLAN TCC representative position. The TRANSPLAN TAC recommended the appointment of Billilee Saengchalern (Oakley) to the vacant TRANSPLAN TCC representative position.

Ms. Saengchalern's term would last two years and expire on December 10, 2027.

Once approved, TRANSPLAN staff will notify CCTA of the TRANSPLAN representative appointment to the TCC.

Recommendation

APPOINT a TRANSPLAN Committee member as the even-year *primary* representative to the CCTA Board for the 2/1/2026 through 1/31/2028 term.

APPOINT a TRANSPLAN Committee member as the even-year *alternate* representative to the CCTA Board for the 2/1/2026 through 1/31/2028 term.

Background

The CCTA Board is comprised of eleven (11) elected officials ("Commissioners") who are appointed for two-year terms by the Regional Transportation Planning Committees ("RTPCs") as follows, two appointed members each from SWAT, TRANSPAC, TRANSPLAN, and WCCTAC, the Conference of Mayors (one appointed member), and the County Board of Supervisors (two appointed members).

The CCTA Board is empowered to administer the Expenditure Plan, the Growth Management and Congestion Management Programs, and to determine the use of sales tax revenue in conformance with the parameters established in Measure J (2004). CCTA also serves as Contra Costa's Congestion Management Agency, and as such, has final approval of the County's Congestion Management Plan ("CMP") and the Countywide Transportation Plan ("CTP").

Commissioner Ron Bernal and Commissioner Juan Banales's terms as the even-year TRANSPLAN representative and alternate, respectively, on the CCTA Board will be expiring on 1/31/2026. CCTA has requested that TRANSPLAN make appointments to the CCTA Board for the two-year period from 2/1/2026 through 1/31/2028. The history of TRANSPLAN appointments to the CCTA Board is enclosed.

CCTA Representative Protocol

The Committee should be aware of the provisions in the CCTA Administrative Code regarding the appointment of Commissioners to the CCTA Board (relevant excerpts below):

- "The Board shall consist of the following: (2) Two members from TRANSPLAN, each of whom is an Elected Official." (CCTA Admin. Code Ch. 1, Art. III, 103.2)
- "Each participating Commissioner shall also have a designated alternate and may have a designated second alternate..." (CCTA Admin. Code Ch. 1, Art. III, 103.2(b))

- "An Elected Official may be designated by more than one Commissioner as an alternate, provided that such Elected Official shall not simultaneously serve on behalf of more than one Commissioner." (CCTA Admin. Code Ch. 1, Art. III, 103.2(b))
- "For election or recall of Commissioners, only City and County Elected Officials shall vote, and each City and Board of Supervisors shall have one vote for each such action." (CCTA Admin. Code Ch. 1, Art. IV, 104.3(b))
